Item A-1

Review and Consideration of Municipal Code Section 15.06.100 et seq. Relating to the Art in Public Places Program

Christine Byers, Cultural Affairs Manager, introduced the item; discussed criteria for approving art concepts; the focus on the bottom line for many developers; name changes for departments; the percent for art allocation; building permit valuations; research into other areas in California; and changes made in Santa Monica.

Marla Koosed joined the meeting at 6:16 P.M.

Discussion ensued between staff and Subcommittee Members regarding trends; private vs. public development; the fact that there has been no change to the percentage since 1988; the amount of revenue received for the last ten years; state law that entitles developers to request that their money be sent back if it has not been spent; enforcement by the Finance Department; the Mitigation Fee Act; the League of California Cities; restrictions on spending; and the current number of art pieces in the City.

Additional discussion ensued between Ms. Koosed, staff. and Subcommittee Members regarding the difficulty of making a convincing argument on increasing the percentage; fees that developers are being hit with at this time vs. when the program was created; concern with developers lobbying the City Council to suspend the program; making other changes that would have more lasting impacts; removing exemptions for covenanted low and moderate income and senior citizen housing; other cities that have removed similar exemptions; the feeling that everyone should have art; exemptions from the minimum investment; providing a choice; valuation of artwork; requiring regular appraisal of artwork; identification of gaps in the ordinance; materials provided by the developer to evaluate the concept; preliminary budgets; ADA (Americas with Disabilities Act) language in the guidelines; QR Codes; art behind glass in a lobby; inaccessibility of the Sony Rainbow; accessibility and

visibility requirements; concern with limiting the artform; sustainability; providing stipends or honoraria; staffing criteria; length of the projects; historic documentation; Historic American Building Surveys (HABS) documentation; internal work that is not seen; the need for quality staff support; AB5 prohibiting hiring contract employees year after year doing ongoing work; institutional knowledge; adding cultural equity language; a request to have the developer concepts be provided before the Subcommittee meeting; the inability to provide materials to the Subcommittee that are not made public; restrictions on the way money can be spent; changes to the economy in the past 30 years; other ways of spending money to invest in the arts; creation of a municipal art gallery; placing temporary art installations in empty buildings to build public support for a gallery; grant programs to support the arts in a different way; money given to arts non-profits in the vicinity of the development; developer responsibilities; grants to non-profits for operational expenses; building in a statute of limitations; having a Culver City based requirement rather than a radius-based requirement; ensuring that Cultural Trust Fund money is spent; aligning with current cultural programming needs and economic demands in the City; the Creative Economy Report; proof of the relationship between arts and culture and economic benefits to the City; ensuring that there are always three full time positions; contract management; work that supports what the Art Fund is about; criteria for approving art concepts; and the need for concrete feedback from Members at the next meeting.
