RESOLUTION NO. 2008-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA, GRANTING A PERMIT JOINTLY TO THE CULVER CITY EXCHANGE CLUB AND PYRO SPECTACULARS TO CONDUCT THE ANNUAL FIREWORKS DISPLAY SPONSORED BY THE CITY OF CULVER CITY AND THE CULVER CITY EXCHANGE CLUB TO BE HELD ON JULY 4, 2008.

WHEREAS, the City of Culver City and the Culver City Exchange Club co-sponsor the City's annual fireworks display every Fourth of July; and

WHEREAS, pursuant to Culver City Municipal Code (CCMC) Sections 9.02.210 and 9.02.220, the City Council, by resolution, may grant a permit to conduct a public display of fireworks on July 4th; and

WHEREAS, the Exchange Club and Pyro Spectaculars have duly applied for and met all application requirements for a permit to conduct a public fireworks display;

NOW, THEREFORE, the City Council of the City of Culver City, California, DOES HEREBY RESOLVE as follows:

1. A permit to conduct a public display of fireworks (the "Event"), is hereby granted to the Culver City Exchange Club and its contractor, Pyro Spectaculars, for the Event to be conducted at Helms Field on July 4, 2008, subject to all of the conditions set forth in CCMC Section 9.02.220.

2. The Exchange Club, on all of its literature, advertising and promotional materials for the Event, shall identify the City of Culver City as a co-sponsor of this Event and the participation of the City of Culver City shall be given equal recognition with the Exchange Club in all matters relating to the Event.

1 3. The Exchange Club shall use its best efforts to insure the consumption
2 of alcoholic beverages does not occur during the Event.

3 4. The City of Culver City hereby agrees to indemnify and hold harmless
4 the Culver City Exchange Club, its officers and members from any and all liability arising
5 out the Event in excess of the \$1,000,000.00 insurance policy procured by Pyro
6 Spectaculars pursuant to CCMC Section 9.02.215.C.
