1 a single week, and residential, commercial or industrial customers having
2 heavy, bulky or large items (such as a major household appliance) to be
3 collected.

4 d. **Commercial can.** This is service provided on a one-time per
5 week basis to commercial or industrial establishments that generate small
6 volumes of refuse each week, and that are unable to use two or three cubic
7 yard refuse bins because of space limitations. Fees are included on the
8 annual property tax statement, unless a tenant established a commercial
9 refuse services agreement with the City.

10 e. **Commercial bin.** This is service provided on a scheduled or
11 on-call basis to residential, commercial or industrial customers who place
12 refuse in refuse bins, and greenwaste in greenwaste bins with a capacity of
13 two or three cubic yards.

14 f. **Temporary bin.** This is service provided on a temporary on-call
15 basis to residential, commercial or industrial customers who temporary
16 require a two or three cubic yard bin. Customers are billed for delivery and
17 retrieval, each pick-up, and for each full month rental.

18 g. **Special bin pick-up.** This is service provided on an on-call
19 basis to commercial bin customers in excess of the frequency specified in the
20 service agreement.

21 h. **Extra bin pick-up.** This is service provided to commercial and
22 temporary bin customers who require a bin to be emptied more than one time
23 during a single collection stop. The customer is responsible for placing
24 refuse into the bin for all extra pick-ups.

25 i. **Bin pull-out.** This is service provided on a scheduled and/or
26 on-call basis to commercial and temporary bin customers who store bins in
27

1 locations more than 25 linear feet from a point where the collection vehicle
2 can safely pick up and empty the bin.

3 j. **Lock set.** This is service provided to commercial and
4 temporary bin customers who require locking devices on refuse bins. The
5 locking devices and locks are provided by the City.

6 k. **Industrial.** This is service provided on a scheduled or on-call
7 basis to public, commercial or industrial enterprises that generate large
8 volumes of solid waste. This service includes providing the customer an eight
9 to fifty cubic yard capacity debris box or a customer-supplied compactor
10 container. A City-supplied debris box must be picked up and emptied at least
11 once every fourteen calendar day period.

12 l. **Transfer and disposal.** This service includes dumping solid
13 waste at the City refuse transfer station and transporting it to an authorized
14 disposal or salvage site. Customers who deliver refuse to the refuse
15 transfer/recycling station and industrial customers pay for this service on a
16 per-ton basis. Transfer and disposal costs for other customers are included
17 in the collection fees.

18 m. **Scooter collection.** This service includes emptying refuse
19 receptacles placed in public places for use by pedestrians.

20 n. **Waste reduction and recycling incentive.** This service is
21 provided to commercial or industrial customers who separate recyclable or
22 salvageable materials from mixed refuse. When the City Sanitation Division
23 is able to divert solid wastes from sanitary landfills, the actual disposal cost
24 may be significantly less. The cost savings may be passed through to
25 customers in the form of reduced rates.

1 2. The rates for each service defined in Section 1, shall be as follows:

2 a. **Residential, single. \$26.83 per dwelling unit per month.**

3 b. **Residential, multi. \$26.83 per dwelling unit per month.**

4 c. **Special, bulk pick-up. \$39.55 minimum charge.** Charges
5 may be increased in **\$19.77** increments based on volume, weight or shape.
6 The City will provide a binding estimate before providing the service.

7 d. **Commercial can (trash). \$24.39 per billing unit.** One billing
8 unit is the monthly charge for collection of up to ½ cubic yard of refuse each
9 week. The service agreement shall set forth the number of billing units for
10 each commercial can customer. **Commercial can (recycle). \$11.50 per**
11 **billing unit.** One billing unit is the monthly charge for collection of up to ½
12 cubic yard of mixed recyclables every other week. The service agreement
13 shall set forth the number of billing units for each commercial can customer.

15 e. **Commercial bin.**

16 1) 2 cubic yards: Refuse, **\$104.31** per month per bin for
17 one weekly collection. Greenwaste, **\$39.64** per month per bin for one
18 weekly collection. Additional weekly collections will be billed based on
19 multiples of this fee.

20 2) 3 cubic yards: Refuse, **\$128.13** per month per bin for
21 one weekly collection. Greenwaste, **\$41.84** per month per bin for one
22 weekly collection. Additional weekly collections will be billed based on
23 multiples of this fee.

24 f. **Temporary bins and on-call service.**

25 1) Pull out: **\$6.42**

26 2) Delivery/removal/re-spot: **\$8.01**

- 3) Collection, on-call: Two (2) cubic yard bin: Refuse,
\$26.70/each collection.
- 4) Collection, on call: Two (2) cubic yard bin: Greenwaste,
\$8.01/each collection.
- 5) Collection, on call: 3 cubic yard bin: Refuse,
\$40.07/each collection.
- 6) Collectionon-call: 3 cubic yard bin: Greenwaste,
\$8.70/each collection.
- 7) Bin Rental Fee: A prorated charge of **\$42.20** per month
will be assessed to a customer using a temporary bin.

g. Special/reload bin pick up.

- 1) 2 cubic yard: **\$26.70** per event.
- 2) 3 cubic yard: **\$40.07** per event.

h. .

i. Bin pull out. \$29.10 per month, per bin.

j. Lock set. \$8.81 per month per lock set.

k. Industrial.

- 1) Container re-spot: **\$35.00**
2. Container empty or removal: **\$156.12** per event, (plus
transfer and disposal tonnage fee, with transfer and disposal fee being
based on a minimum charge for 2 tons).

l. Transfer and Disposal.

- 1) Trash - first eleven (11) tons: **\$77.76** each ton,
measured to the nearest 100th of a ton.
- 2) Trash - over eleven (11) tons: **\$155.53** each ton,
measured to the nearest 100th of a ton.

1 3) Asphalt - **\$44.44** each ton, measured to the nearest 100th
2 of a ton.

3 4) Asphalt – over eleven (11) tons **\$88.88** each ton,
4 measured to the nearest 100th of a ton.

5 5) Metal - **\$10.76** each ton, measured to the nearest 100th
6 of a ton.

7 6) Metal - over eleven (11) tons **\$21.52** each ton, measured
8 to the nearest 100th of a ton.

9 7) Inert - **\$49.85** each ton, measured to the nearest 100th of
10 a ton.

11 8) Inert - over eleven (11) tons **\$99.70** each ton, measured
12 to the nearest 100th of a ton.

13 9) Clean wood - **\$40.83** each ton, measured to the nearest
14 100th of a ton.

15 10) Clean wood - over eleven (11) tons **\$81.66** each ton,
16 measured to the nearest 100th of a ton.

17 11) Contaminated wood - **\$49.85** each ton, measured to the
18 nearest 100th of a ton.

19 12) Contaminated wood - over eleven (11) tons **\$99.70** each
20 ton, measured to the nearest 100th of a ton.

21 13) Greenwaste - **\$49.85** each ton, measured to the nearest
22 100th of a ton.

23 14) Greenwaste - over eleven (11) tons **\$99.70** each ton,
24 measured to the nearest 100th of a ton.

25 9) Drop-body Rental Fee: A prorated charge of **\$137.80** per
26 month will be assessed to a customer using a drop-body.

1 3. Waste reduction and recycling incentive. The Sanitation Manager
2 shall establish incentive rates for recyclable materials based on current market conditions.
3 Incentive rates may be applied to the following services.

- 4 a. **Commercial bin.**
5 b. **Temporary bin.**
6 c. **Special bin and bulk pick up.**
7 d. **Extra bin pick up.**
8 e. **Transfer and disposal.**

9 4. The City Council hereby directs the creation of the Refuse Service
10 Lien Master File List Computer Floppy Disk and orders the annual levy of Refuse Service
11 Fees on each parcel of property as shown and set forth in the computer floppy disk.

12 5. The Los Angeles County Auditory-Controller shall enter on the County
13 Assessment Roll the amount of the fee on each parcel and the fee shall then be collected
14 at the same time and in the same manner as County Property Taxes are collected. After
15 collection, the net amount of the fee shall be paid to the City Treasurer of Culver City and
16 the money shall be placed in the Refuse Disposal Enterprise Fund.

17 6. The City Clerk is hereby ordered and directed to file a copy of said
18 computer floppy disk, together with a certified copy of the Resolution with the Los Angeles
19 County Auditor-Controller.

20 7. A certified copy of the Refuse Service Fee Lien Master File Listing
21 Computer Floppy Disk shall be kept on file, under control of the City Clerk, at all times and
22 shall be available for public inspection.

23 8. The Refuse Collection Fees set forth in Section 2 that have not been
24 billed through the Refuse Service Fee Lien Master File Listing Computer Floppy Disk shall
25 be collected pursuant to billing procedures established by the City Treasurer.

26 9. Resolution No. 2006-R050 is hereby rescinded.
