Sally Unsworth, Cultural Affairs Manager, provided a summary of the material of record.

Discussion ensued between staff and Commissioners regarding concerns with vandalism; the temporary structure; tile integrity; durability; the memorial; incorporation of Commission recommendations; the general and community collaborative proposal; absence of a memorial component in the revised project; tilemaking at festivals with a concluding program onsite; appreciation for the incorporation of Commission feedback; and the adjusted budget.

# for the Farragut Connector Project, and 3) \$10,000 to create and install the tribute to the area's racetrack history within the Farragut Project

Sam Lee, Cultural Affairs Analyst, provided a summary of the material of record and introduced Sonia Romero.

Sonia Romero discussed the design that is based upon the surrounding neighborhood and references to the racetrack that was located in the area; the shape of the existing street as echoing the racetrack; the outer ring signifying Ballona Creek; Carlson Park; and the tile design seen when entering the Farragut Connector.

Sam Lee, Cultural Affairs Analyst, discussed the concept vs. the final design; influences; history of the area; single family homes; graphics from vintage toys; use of Cuerda Seca tiles; fabrication of individual tiles in collaboration with Tile Guild; artist experience with all stages of the process; budget; timeline; and next steps.

Discussion ensued between staff and Commissioners regarding support for the artist and the proposal; potential changes between the concept and the final project; feedback; openness adjustments; appreciation to making for the educational/historical component; a suggestion to add an aspect of community into the project; support for adding bicycles and pedestrians to the project; future discussions on how to incorporate community into the project; resources budgeted toward public engagement activities; the bustling and community-centered location; and neighborhood participation.

1) Discuss Potential Revisions to Culver City Municipal Code Section 15.06.100 et seq. Relating to the Art in Public Places Program Allocations; and, 2) Provide Recommendations to the City Council As Desired

Sally Unsworth, Cultural Affairs Manager, provided a summary of the material of record.

Discussion ensued between staff and Commissioners regarding appreciation for the well-researched definitions and clear language; the uniqueness of Culver City; facilities in Culver City; arts equity; support for doing the Cultural Equity Plan before doing anything further with performing arts allocations; partnership with Economic Development; the Summer Music Series; the jazz series; Music in the Chambers; support for the revisions; inclusion of the Community Arts Equity Plan in the Work Plan; completion of the General Plan; and upcoming subcommittee meetings.

Vice Chair O'Carroll read a statement from the Culver City Arts Foundation about proposed changes to the Art in Public Places Ordinance; discussed purposes of the fund; the fact that not enough funds from any one project are generated to create a sizable facility; and a suggestion to expand the purpose by creating a provision in the ordinance that would allow Cultural Trust Fund fees to be pooled with other developments for use in constructing a significant and appropriate municipal art gallery or performing arts center.

Discussion ensued between staff and Commissioners regarding limitations with the way the ordinance is presently written; the need to embark on the Community Arts Equity Plan first; current choices for developers in how they fulfill art requirements; providing an official mechanism to pool funding ; larger developments that opt to do art on site; earmarking a certain percentage of each developer's fees to pool toward

one large project; further consideration as part of the Community Arts Equity Plan; making the choices available for developers very clear; the Art in Public Places Program; the need to proceed cautiously; having more of a say in how money in the Cultural Trust Fund is used; making a recommendation as to whether the December 19 revisions proceed; continued work through a long-range planning process; review of the Commission recommendation by the City Attorney before it goes to the City Council; and the ordinance process.
