Re: Culver City Fireworks Show – July 4th, 2023

Honorable Mayor Albert Vera and City Council,

The Exchange Club of Culver City seeks the City's financial and in-kind support for its 53rd annual Fireworks Show to be held at West Los Angeles College on July 4th, 2023. This event has long been a tradition in Culver City attracting families and children of all ages. This event is multi-generational – with parents who once attended the show as children now bringing their own children and grandchildren to this family friendly patriotic celebration.

Historically, the event has been a way to promote public safety inviting the public to professional fireworks show to discourage the use of private illegal fireworks. It for this reason that both the Culver City Fire and Police Departments support this event.

All net proceeds (after expenses) from this charity event are funneled directly back into the Culver City Community to support youth programs (e.g., Sandy Segal Youth Health Center and Y.M.C.A.) and the many college scholarships that we provide to needy and deserving local high school students. The monies raised are also directed to support efforts to end homelessness among in our local Veteran Community.

The Exchange Club seeks the following support from Culver City:

1. \$34,000.00 is directed to underwrite the cost of the fireworks production.
2. In-kind services in the form of Culver City Police Department traffic control on the roadways leading and out of the college. CCPD projects that it will require between 4 and 6 personnel to undertake this task.
3. Approval of City sponsorship to secure a waiver of fees associated with the installation of street banners advertising the show.
4. The use of available changeable message boards to supplement and enhance traffic control into and out of the event.

The Exchange Club will underwrite all other expenses associated with this event. These expenses include but are not limited to the following types of costs: 1) facilities and staff charges from WLAC; 2) law enforcement costs associated with security for the event (e.g., Los Angeles County Sheriffs) ; 3) rental costs relating to items such as stage, generators, porta-potties, security fencing; portable lighting, golf carts for volunteer staff, etc. 4) entertainment costs for band, sound system and additional stage lighting; 5) promotion and advertising;
