# Discussion and Recommendation on Funding for and Management of Crossing Guards by the City and CCUSD

Ted Stevens, Culver City Parks, Recreation and Community Services Director, provided a summary of the material of record.

Discussion ensued between staff and Committee Members regarding allowing for public discussion; increased costs; shared facilities; mutual support; the importance of transparency when dealing with the public's money; money already being spent by Culver City to support CCUSD; community facilities that CCUSD has; the fact that the MOU (Memorandum of Understanding) has not been updated; school facilities that are closed and unused during off hours; helping Culver City as part of collaboration and partnership; fulfilling the MOU; previous CCPD (Culver City Police Department) responsibility for crossing guards; suggestions for locations that would benefit from a crossing guard; the Los Angeles Department of Transportation (DOT) policy that creates a clear line of expectation; other intersections that would be useful; an intersection where a crossing guard was deployed because a stop sign could not be installed; appreciation for upgrades made by Culver City; increased delineation and perceived safety; anecdotal evidence; and lack of equity or a comprehensive study.

Additional discussion ensued between staff and Committee Members regarding the comprehensive study through the neighborhood surrounding the tri-school complex to see what is needed where; available options; outreach; study costs; the stop-gap measure; additional requests for crossing guards; the focus on Elenda; creation of a formal process for engagement; making the best decision rather than being reactive; volume of pedestrians in intersections; examining hot spots; the contract with ACMS; managing ongoing requests in a data-driven fashion; making a recommendation to the City Council regarding funding and management of crossing guards; the big ask that Culver City pay for the crossing guards; the ability to make a recommendation; the increased amount of the request; policy decisions made by the City Council; delays to the MOU; ensuring that Culver City gets credit; the need to be thoughtful when asking for funds; the need for reciprocal effort; making an argument for any intersection in Culver City; inattentive drivers; the fact that crossing guards cannot be added each time a community member makes a request; community access to CCUSD facilities; putting processes in place; the timeframe for completion of the study; the need to wait until the fall to gather data; addressing the crossing guard request at Virginia and Overland; and comparisons other Overland crossings.

Further discussion ensued between staff and Committee Members regarding appreciation for the consideration and support; the study indicating the need for the additional crossing guard; the overdue addition; an anecdotal survey of neighboring school districts regarding responsibility for crossing guard costs; community feedback regarding the feeling of safety and security with crossing guards; ensuring a clear process is established; conducting a City-wide analysis for the 2025-2026 school year; intersections that might be eliminated after the study; community support for the additional coverage; future exploration of whether Capital Improvements can change intersection conditions to eliminate recurring costs; support for having Culver City fund wider costs; contract management; parent perception that the School District manages the crossing guards; substitutes; use of a contractor; streamlining communications; neighbor feedback regarding responsiveness to concerns; and joint consideration of future requests.

Chair McMorrin invited public comment.

Jeremy Bocchino, City Clerk, indicated no requests to speak had been received.

MOVED BY MEMBER O'BRIEN, SECONDED BY MEMBER EZIDORE AND UNANIMOUSLY CARRIED, THAT THE CITY OF CULVER CITY/CULVER CITY UNIFIED SCHOOL DISTRICT LIAISON COMMITTEE:

1. APPROVE THE ADDITIONAL REQUEST TO HAVE A CROSSING GUARD AT OVERLAND AND VIRGINIA; AND,

2. HAVE CULVER CITY PAY FOR THE ADDITIONAL COSTS FOR THE GUARD ON TOP OF THE ORIGINAL REQUEST FOR \$179,000; AND,

3. HAVE CCUSD TAKE ON MANAGEMENT OF THE ACMC CONTRACT; AND,

4. DIRECT THAT FUTURE CROSSING GUARD REQUESTS RETURN TO THE COMMITTEE UNTIL SUCH TIME AS THE ANALYSIS IS COMPLETE AND SYSTEMS ARE IN PLACE.
