Services Requested: Perform field investigative services and provide reports.

Service Agreement dated as of March 22, 2010, between CITY OF CULVER CITY (hereinafter referred to as "CLIENT") and RJN Investigations, Inc. (hereafter referred to as "RJN").

1. CLIENT agrees to pay RJN for all services rendered regardless of the outcome of said services.
2. CLIENT shall pay a retainer of \$1000 against costs. (WAIVED)
3. CLIENT agrees to pay RJN for all work undertaken or to be undertaken at the rate of \$68 per hour billed at quarter hour increments plus all associated expenses. It is agreed that any and all courts appearances pertaining to this case are billed at the rate of \$68 per hour plus associated expenses.
4. CLIENT acknowledges that the information contained in such reports is obtained from sources including, but not limited to, public records, nonproprietary services and through observation or perception, which may require the exercise of judgment of interpretation. CLIENT further releases RJN, its officers, employees, and affiliated companies and any companies or individual from which RJN obtains information included in a report, from the liability arising or alleged to arise directly or indirectly from any negligent acts, errors, or omissions by any of the providers of information or RJN in connection with the preparation of any reports, written or verbal.
5. By requesting and receiving reports, the CLIENT agrees to indemnify and hold harmless RJN, its officers, and employees from any and all claims, liabilities, expenses, fees including attorney fees, costs, and judgment arising from CLIENTS use or possession of the information furnished in said report.

6. CLIENT agrees that RJN is engaged **solely by CLIENT**, and that **CLIENT is completely responsible for payment within** thirty days from receipt of report and invoice. A 1.5 % per month service charge will be charged on unpaid balance over thirty days.
