# Receive Summary Report of FY 2024-2025 Cultural Affairs Work Plan Priorities and Provide Comments to the City Manager as Appropriate

Sally Unsworth, Cultural Affairs Manager, thanked staff, Commissioners, and other City representatives for the warm welcome; congratulated Katy Krantz on the "Dear Culver City" event; discussed one-on-one meetings with Commissioners and meetings with staff; APPP (Art in Public Places Program) projects; development of strategies for replacement of bronze historical markers; and she provided a report on Fiscal Year 2024-2025 Cultural Affairs Work Plan priorities.

Discussion ensued between staff and Commissioners regarding appreciation for the report and for the overview of work done and to be done; the May "Mondo" Olympic meeting; appreciation for the Director's experience with community cultural planning; and excitement about potential partnerships to place art in empty storefronts.

# Consideration of Cultural Affairs Commission Regular Meeting Scheduled on May 21, 2024 and Make Recommendation as Appropriate ${\bf May}$

Sally Unsworth, Cultural Affairs Manager, noted that the regular meeting date conflicted with a City Council budget meeting.

Discussion ensued between staff and Commissioners regarding scheduling; location; potential agenda items for May; the Public Art Subcommittee meeting report-out; potential recommendations regarding the municipal code allocations; an April 12, 2024 Los Angeles Times article about a Supreme Court ruling allowing developers to challenge municipal development fees; concern that a conversation regarding changing the codes could be inappropriate; staff agreement to research and return with additional information; and ensuring that relevant data is considered.

Commissioner Fleischer indicated that she would be absent for the regular May Commission meeting.

Additional discussion ensued between staff and Commissioners regarding a planned Artist Laureate Subcommittee meeting in June; staff availability; scheduling; noticing requirements; the staff presentation at the City Council budget meeting; the budget meeting with Finance; and staff workload.

Sally Unsworth, Cultural Affairs Manager, thanked Katy Krantz and everyone involved in the "Dear Culver City" event.

Commissioner Fleischer thanked Sam Lee for his efforts organizing the "Dear Culver City" event; discussed the vision; extending the exhibition past the June date; the summer concert series; foot traffic; and she expressed appreciation to Lee Lawlor for her list of Performing Arts Grant events.

Lee Lawlor, Cultural Affairs Analyst, noted that dates were subject to change.

Commissioner Wisnosky Stehlin thanked staff for their efforts on the "Dear Culver City" event, and she expressed appreciation to Commissioner Fleischer for her advocacy.

Commissioner Fleischer said that Katy Krantz could be the springboard, and an example for creating a municipal artist in residence program in the city; discussed embedding artists in Culver City government to facilitate communication with the public and help with creative ideas on how to handle City operations; programs in other cities; and she felt that the program would be appropriate for the City.

Vice Chair O'Carroll echoed Commissioner comments; thanked Katy Krantz for her work and for her efforts to involve the community; stated that Katy Krantz had embodied the spirit of community and had not chosen to promote her own art; and she expressed support for having a municipal artist in residence.
