17	notion that international conflicts should be addressed through dialogue and diplomatic
18	means at the federal level, rather than through action by the City Council; and

20	WHEREAS, while we acknowledge the global context of international conflicts,
21	the City Council emphasizes the importance of focusing on local initiatives that promote
22	peace, social cohesion, and the well-being of our residents; and
23	WHEREAS, we commit to maintaining transparency and accountability in the
24	allocation of City resources, ensuring that both time and funds are spent wisely, and our
25	priorities as a City are centered on our community and focused on local impact; and

12	2. The City of Culver City is committed to the responsible use of the time
13	and resources of City staff, and elected and appointed officials.
14	3. The City of Culver City reaffirms its role as a compassionate and
15	responsible community, committed to standing with all those who seek peace, while also
16	focusing on strengthening our local efforts to create a more just and peaceful world.
17	4. By adopting this resolution, the City of Culver City invites its residents
18	and leaders to join in its ongoing commitment to these values, fostering a future where
19	peace prevails for all.
