

RESOLUTION NO. 2016-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA. ESTABLISHING FEES FOR POLICE AND FIRE DEPARTMENT PERSONNEL REQUIRED TO BE RETAINED BY FILMING ACTIVITY AND SPECIAL EVENT PERMITTEES, PURSUANT TO CULVER CITY MUNICIPAL CODE §§ 11.14.035 AND 17.520.030.

WHEREAS, Culver City Municipal Code (CCMC) §11.14.035 requires film permittees to retain Culver City Police Department personnel to be present at all times during filming activity and Culver City Fire Department personnel to be present during filming activity, as required by the Fire Code, all at the permittee's sole cost and expense;

WHEREAS, pursuant to CCMC §17.520.030, special event permittees may be required, as part of the event conditions of approval, to retain Police and Fire Department personnel as determined by the City in order to address security and safety issues; and

WHEREAS, the City Council desires to establish a fee schedule for these filming activity and special event assignments of the Police and Fire Department personnel, which fees shall be paid by the respective permittees; and

WHEREAS, on May 23, 2016, at a duly noticed public meeting of the City Council, after giving the public an opportunity to be heard and considering all information before it, the City Council approved the adoption of said fees as set forth in this Resolution; and

WHEREAS, the fees established herein are based upon the reasonable cost of providing the services and regulatory activity required by CCMC Sections 11.14.035 and 17.520.030; and

1 NOW, THEREFORE, the City Council of the City of Culver City, California,
2 DOES HEREBY RESOLVE as follows:

3 The City Council does hereby establish the fees for Police and Fire
4 Department personnel required to be retained by filming activity and special event
5 permittees, pursuant to CCMC Sections 11.14.035 and 17.520.030:
