Edgar Varela, Special Events Manager, presented Juneteenth event flyers for anyone interested in distributing them and he displayed designs for historical markers.

Discussion ensued between staff and Committee Members regarding the ability to discuss the slides; deletion of the entire Vital Statistics slide; ensuring the slides are uplifting for the celebration; posters; the ability to pull things but not to add items; concern that nothing is included in the slides about the origin of Juneteenth; and consideration of the slides by the History and Culture for Juneteenth Ad Hoc Subcommittee.

Juneteenth; the explanation of Juneteenth by a speaker included on the Run of Show; the ability to provide a paragraph with the history of Juneteenth; including Member Smith as an orator in the Run of Show; the feeling that the more the Committee is involved, the better the event will be; the goal of the passports to encourage people to engage; use of volunteers; ensuring it is not hard to get stamps; a suggestion to allow people to post photos of the event and tag Culver City to get a stamp; number of vendors and booths; presence of City department booths; appreciation for the passports; the in memoriam video; and the ability to email staff with questions.

Dorian Jackson, Associate Analyst, expressed appreciation for the hard work of the Committee; discussed procedures; strict City rules; the importance of not using personal email that could be subject to public records requests; phone numbers; and items that are part of the public record.

Discussion ensued between staff and Committee Members regarding appreciation for the reminder; a request that staff illustrate how Committee Members can accomplish the overall mission; protocols; the definition of contact information; names listed on the Run of Show; text messages; Committee business discussed in a group chat with more than 4 people as a violation of The Brown Act; messages sent to the full Committee alerting them of being late as a violation of The Brown Act; and The Brown Act presentation scheduled for the July meeting.

Adam Ferguson, Senior Management Analyst, reported that Recreation and Community Services Manager Francisca Castillo was on administrative leave so he would be handling some of her duties in her absence, and he encouraged anyone with questions about the Committee to reach out to him or to Dorian Jackson.

Chair Hearns thanked everyone for their work; expressed appreciation for the work of the subcommittees; thanked people for being present at the event and for the City Council proclamation; and she was looking forward to the event.
