Presentations

Item P-1

Report from Staff

Charles Herbertson, Public Works Director, introduced the presentation on the Culver City Active Transportation Program Cycle IV grant application.

Sanjana Mada, Bicycle and Pedestrian Coordinator, provided a presentation on the Culver City Active Transportation Program Cycle IV grant application.

Discussion ensued between meeting participants, staff and Committee Members regarding aggressive bicycle riders; right of way; not taking space out of the pedestrian path; different options; construction; concern with space issues related to putting in a two-way bicycle lane; concern with a bikeway traversing store fronts; riding and pedestrian behaviors; concern with putting a bike lane in a pedestrian right of way and potential conflicts; and participation by Committee Members at the City Council presentation.

Sanjana Mada, Bicycle and Pedestrian Coordinator, provided an overview of actions by the City Council regarding Bird Scooters; she indicated that Bird and Lime would operate in Culver City with an initial deployment of 200 scooters per operator; she discussed the dynamic cap; initial documents; securing safety for the community; maintenance requirements; balancing; access to the operating agreement; the parking plan; required reports regarding usage and safety; and revenue sharing.

Discussion ensued between staff and Committee Members regarding scooter speed limits; operator responsibility for safety; City impounding of scooters left over 24 hours; enforcement; responsiveness; the six-month trial period; warnings; available options; user requirements; and current riders.

Sanjana Mada, Bicycle and Pedestrian Coordinator, discussed restrictions for riding bicycles on sidewalks in Culver City.

Police Lieutenant noted that sidewalks are engineered for pedestrian travel; he discussed reducing conflicts between pedestrians and moving objects; current use of sidewalks; enforcement and children riding on the sidewalks; limited travel space on the sidewalk; concern that pedestrians are limited to traveling the sidewalk while bicycles and scooters have other routes available; aggressive riders; the downtown area; the inability to regulate speed on the sidewalk; the difficulty of establishing priority or right of way on a sidewalk; concern with injury claims against the City; anticipated behavior; increased possibility of conflicts; discretion with citations for bicyclists; safety for cyclists on the roadways; and the intent of the bicycle network plans to address issues.

Discussion ensued between staff and Committee Members regarding regular bicycle vs. car conflicts; whether it could be allowable for cyclists to use sidewalks, if they are empty, for safety reasons; defining business districts; the vehicle code; a suggestion to take a lane of traffic for bicycles and scooters; taking space away from cars; clarification that motorized vehicles are not allowed on the sidewalk; education; data indicating multiple car and bicycle engagements per week but no bicycle and pedestrian engagements; keeping the status quo; designation of critical segments; electric bike share; making a rule that if bicycles are allowed on a sidewalk that they have no right of way; concern with complicated, hard to follow rules; state code; concern with nebulous wording; requirements that cars and bicycles yield to pedestrians; requiring dismounting before passing pedestrians; the three tiers of electric bikes; current policy identifying Segways as pedestrians; helmet requirements; concern with confusion; addressing issues at the state level; addressing areas with high levels of pedestrian traffic; agreement to focus on bike lanes and building a preferred space for bikes; concern with creating rules before bicycle infrastructure has been established; and Committee consensus not to make changes to requirements at this point.

Sanjana Mada, Bicycle and Pedestrian Coordinator, discussed the Go Human demonstration on Elenda Street; having a parking protected cycle track on Elenda Street from Washington to Culver; the community outreach and engagement

process; planned events; the advisory committee; and she encouraged submission of suggestions.

Discussion ensued between staff and Committee Members regarding the upcoming advisory committee meeting; the cycle track; clarification that there will not be any road closures; the ability of Members to participate in the demonstration and provide feedback at the next BPAC meeting; and encouragement to Committee Members to submit any questions or concerns to staff.

Sanjana Mada, Bicycle and Pedestrian Coordinator, provided an update on the Open Streets grant and the Bicycle and Pedestrian Master Plan, and she discussed holding the discussion on Bike Share pending comment from the City Council.

Discussion ensued between staff and Committee Members regarding the Bicycle Action Plan.

procuring helmets; appreciation to Mary Daval for her comments; appreciation to Women on Bikes; the role of the Committee; providing an opportunity for Members to bring items to the Committee; agreement to add Items for Future Discussion to the regular agenda; the General Plan Update Committee; communication; the Bicycle and Pedestrian Master Plan; the conduit between the Committee and the City Council; and training for new Members.
