4 CULVER CITY, CALIFORNIA, INITIATING PROCEEDINGS
5 FOR THE LEVY AND COLLECTION OF ASSESSMENTS FOR
6 THE BENEFIT ASSESSMENT DISTRICT WEST
WASHINGTON BOULEVARD NO. 1 AND ORDERING THE
PREPARATION OF AN ASSESSMENT ENGINEER'S REPORT

7 WHEREAS, the City Council previously completed its proceedings pursuant
8 to the provisions of Chapter 15.01 of the Culver City Municipal Code ("CCMC") for the
9 formation of a benefit assessment district known and designated as the "City of Culver City
10 Benefit Assessment District West Washington Boulevard No. 1" (hereinafter referred to as
11 the "District"); and

13 WHEREAS, these proceedings for the annual levy of assessments shall
14 relate to the fiscal year commencing July 1, 2011 and ending June 30, 2012; and

15 WHEREAS, the City has retained the consulting firm of NBS for the purpose
16 of assisting with the annual levy of assessments and preparation of an Assessment
17 Engineer's Report (the "Engineer's Report"), to be filed with the City Clerk in accordance
18 with CCMC Section 15.01.055.

20 NOW, THEREFORE, the City Council of the City of Culver City, DOES
21 HEREBY RESOLVE as follows:

23 1. The City Council hereby orders the preparation of the Engineer's
24 Report in accordance with the requirements of CCMC Section 15.01.055, to be filed with
25 the City Clerk for submission to the City Council. The Engineer's Report shall be prepared
26 by NBS and approved by the City Engineer prior to filing with the City Clerk.

1 2. There are no changes to existing improvements nor are there any
2 items being added to the list of improvements previously approved at the formation of the
3 District.

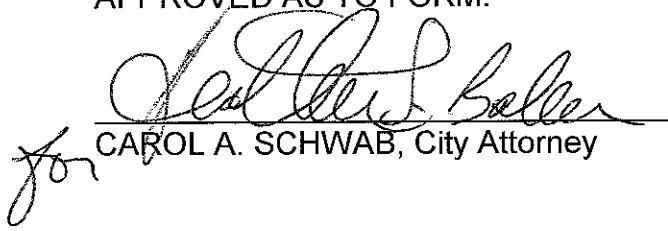
