Presentation to the City Council of a Video Entitled "This is Culver City"

Karen Gibbs, Fiesta La Ballona Committee Member, invited everyone to attend Fiesta La Ballona on August 28-30 and discussed activates and volunteers.

Discussion ensued between staff, Council Members and Centennial Committee Members regarding the time table; Parcel B; alternate locations; the proposed staff person; the website; graphic design; visual identity; social media; engaging young people; diversity on the committee; banners; timing; sponsorships; Culver City past, present and future; the target date for the website launch; timing procedures for speakers; pricing for the gala; and budget adjustments.

Mayor O'Leary invited public participation.

The following members of the audience addressed the City Council:

Rebecca Rona asked the City Council to support Senate Bill 350 and discussed the passing of her former husband Bob Rona.

Rick Tuttle acknowledged the importance of Bob Rona to the community; discussed SB 350; and he thanked Council Member Clarke for his efforts on the Centennial Committee.

Michelle Weiner discussed the City as being a leader; the South Bay Clean Power Community Choice Aggregation; choosing clean energy; participating in a risk free feasibility study; she asked that the item be placed on an agenda for consideration; and she distributed information on the item and a sample of a resolution to participate in the study.

Discussion ensued between staff and Council Members regarding interest from the Westside Council of Governments; consideration in the Sustainability Subcommittee; registered supporters of the Bill; potential increased costs; the threshold to sustain life without climate change; reducing the use of fossil fuel; low carbon options; the Legislative Advocacy Program; legislation that contains unfunded mandates; the effects of support from the City; the intent of the Bill; actions already undertaken by the City; appreciation to Public Works for their efforts toward

sustainability; and leading by example.

MOVED BY COUNCIL MEMBER SAHLI-WELLS, SECONDED BY MAYOR O'LEARY AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: DIRECT THE CITY MANAGER PREPARE A LETTER IN SUPPORT OF SB 350 FOR THE MAYOR'S SIGNATURE.

Introduction of an Ordinance Amending Section 11.15.010, Definitions, of Chapter 11.15, Tobacco Retailer Licensing, of the Culver City Municipal Code, to Require a Tobacco Retailer License for the Sale of Any Electronic Smoking Device or Electronic Smoking Device Paraphernalia

Mayor O'Leary invited public participation.

The following members of the audience addressed the City Council:

Sherwood Kingsley, Cancer Action Network, expressed support for amending the ordinance to include e-cigarettes and discussed preventing underage smoking.

Primo Castro, Cancer Action Network, expressed support for the amendment to add electronic cigarettes to the ordinance, and he discussed the targeting of youth.

Aneena Pokkamthanam, Los Angeles County Department of Public Health, thanked the City for its leadership in tobacco control; discussed teen use of e-cigarettes; reducing youth access; the need for more research; taking a precautionary approach; and she reported that the Department recommended amending existing tobacco licensing ordinances to include e-cigarettes as a tobacco product which would require obtaining a tobacco license that would discourage sales to minors.

Jane Steinberg expressed support for an ordinance requiring a tobacco retail license for the sale of e-cigarettes and other electronic devices in the City and she discussed use of e-cigarettes by American youth.

Violet Ruiz, American Heart Association, expressed support for amending the ordinance to include e-cigarettes; she discussed public health measures; chemicals known to cause cancer, birth defects and other reproductive harm; and youth

access to tobacco products.

Discussion ensued between staff and Council Members regarding whether e-cigarettes can help people quit cigarettes; concern with opening the door to the next generation; providing the ability to take action if shops are selling to minors; and clarification that notice was given to e-cigarette retailers.

MOVED BY COUNCIL MEMBER CLARKE, SECONDED BY COUNCIL MEMBER COOPER AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: INTRODUCE AN ORDINANCE AMENDING SECTION 11.15.010, DEFINITIONS, OF CHAPTER 11.15, TOBACCO RETAILER LICENSING, OF THE CULVER CITY MUNICIPAL CODE, TO REQUIRE A TOBACCO RETAILER LICENSE FOR THE SALE OF ANY ELECTRONIC SMOKING DEVICE OR ELECTRONIC SMOKING DEVICE PARAPHERNALIA.

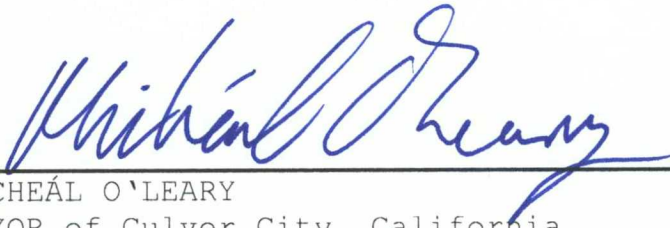
