Luther Henderson accepted the proclamation on behalf of the citizens of Culver City and his wife, Patricia Siever who formerly taught African American History at West Los Angeles College; he discussed Black History Month; Jelly's Last Jam; recognition of the arts; the growth of Culver City as a Mecca for the Arts; and he indicated being proud to be a resident.

Community Announcements by Members/Updates from Commission, Boards and/or Committees/Information Items from Staff

Council Member Puza thanked City staff for their actions during the recent storms; wished a Happy Lunar New Year to those who

observe; discussed the Winter Holiday Party by the Downtown Business Association (DBA) on January 31 at the Culver Hotel; and he announced the Walk and Rollers E-Bike Safety Workshop on February 17.

Vice Mayor O'Brien discussed a recent community meeting about Bill Botts and Veterans Park; valuable feedback received; the ongoing process; the final consultant presentation in March; and he reported that he and Council Member Puza had attended a meeting with the Romanian Health Minister at Southern California Hospital.

Mayor McMorrin wished everyone a Happy Valentine's Day and Happy Lunar New Year to those who celebrate; discussed American Heart Month; the inaugural Black History Month Event at the Westfield Culver City Mall and the potential for future collaboration with the City; co-sponsorship of a screening of the film, Origin; she thanked City staff and first responders in the region for their efforts during the state of emergency with the recent rains; reported on the availability of Misfortune and Calamity Relief for Storm-Related Damages available assessor.lacounty.gov/disaster as well as а Homeowner's Exemption discount on taxes; discussed working toward more effective City Council meetings; support for adding items to the agenda from all colleagues; being open to debating issues; listening to public comment; accomplishing what Council Members were elected to do; shared priorities; and draft strategic priorities for the City being discussed on February 16, 2024.

Joint Public Comment - Items NOT On the Agenda

Mayor McMorrin invited public comment.

Jeremy Bocchino, City Clerk, read a statement regarding hate speech.

The following members of the public addressed the City Council:

Ronald Davis provided background on himself; asked that the City Council pass a resolution calling for the immediate cease-fire in the Israel/Palestine War to be sent to President Biden and the California Congressional Representatives and Senators at the state and federal level; discussed the number of casualties and damage on both sides; lack of humanitarian aid in Gaza; he cited Jewish and Palestinian organizations that have joined to

request a cease-fire; noted that numerous city councils across the nation had passed resolutions in support of a cease-fire; and he asked that an item to consider a cease-fire resolution be placed on the agenda for the City Council next meeting.

Fawaz Istwani, Jackson Market, provided background on himself; discussed money raised to help sick and hungry women and children in Gaza; worsening conditions in Gaza; the number of Palestinians killed; people corralled in Rafah; he expressed support for the call for an immediate cease-fire; and he asserted that the issue was humanitarian rather than political.

Brian Lucas, Culver City Unified School District (CCUSD) Superintendent, discussed his reasons for being drawn to serve in Culver City; support for the District; the need to focus on repair of school facilities; goals; and he was looking forward to partnership with the City and mutual support.

Carolyn Libuser discussed Measure E.

Heather Baker, City Attorney, reported concern with comments made at the last City Council meeting noting that campaigning from the podium or in Council Chambers was not allowed; she indicated the need to keep comments neutral; and she clarified that advocacy one way or another for ballot measures was not permissible.

Carolyn Libuser stated that she was not campaigning, but presenting facts; she discussed large contractors and architect firms advocating for Measure E; sizeable donations; financial bond advisors; the amount of money contributed to the campaign; she thanked Bryan Sanders for his investigative work regarding donors; and she questioned who stood to benefit.

Conor Proffitt asked the City Council to join other city councils across the country in the call for a cease-fire in Gaza; discussed injuries and death; trauma to children; asserted that blood could not pay for blood, could not bring back the dead, and could not bring peace; and he read a quote from Palestinian activist and poet Refaat Alareer who was killed by a targeted strike in December.

Denice Renteria, Equity and Human Relations Advisory Committee, reminded everyone that February 29, 2024 was the deadline to make nominations for Equity and Human Relations Awards to honor individuals and organizations for their contributions in equity and inclusiveness; she discussed the four nomination categories

for those with the intention to make a difference in Culver City; she reported that applications were available on the City website and in Council Chambers; and she encouraged people to fill out as much information as they know on the application and not to worry about being 100% complete.

Rebecca Rona Tuttle asked the City Council to agendize a ban on the City's use of plastic water bottles and the local sale of plastic water and soda bottles; she discussed issues with plastic water bottles; the Great Pacific Garbage Patch; methane emissions; and the manufacturing process that is detrimental to the environment.

Council Member Puza encouraged Rebecca Rona Tuttle to attend the Sustainability Subcommittee meeting noting that the item was on the agenda.

Melissa Sanders asked that people come to School Board meetings to get involved; she noted that many people might be unaware of what has been going on and what the new Superintendent has to deal with; she discussed public records requests; and concerns with unethical behavior.

Marta Zaragoza provided a handout that was distributed to Council Members; reported that a volunteer in east Culver City has been waiting for mulch that has been approved for several months; discussed accountability; a truck parked in her neighborhood that should have been ticketed; she felt enforcement should be consistent with the rules followed for all of Culver City; expressed concerns with funds being provided to non-profit organizations that do not have a valid IRS non-profit status; she discussed public information required of non-profit organizations; and she wanted to see guidelines enforced.

Marci Baun noted that the Los Angeles county Office of Education has given CCUSD until the end of February to come up with a budget due to the District being in deficit spending; she asserted that if something was not done, the state would take over CCUSD; she pointed out that the schools were in disrepair; discussed Measure CC bonds; money that was supposed to be set aside to build a new pool facility; money spent on a new science lab that is already falling down; and she asked that The Plunge be opened completely.

Jim Shanman, Safe Routes to School Coordinator, applauded City staff for the installation of new park and walk zones by El Marino and El Rincon, as well as the signing and striping

projects; discussed making areas safe and more biking-friendly; and he announced the E-Bike Safety event at the Culver Palms YMCA on February 17 with sign-ups available at ccwalkandroll.com.

Anthony Higgins echoed previous comments calling for a cease-fire in Palestine; discussed the population and size of Gaza; the effects of bombing on the development of the children; he asserted that the issue was humanitarian, not political; he referenced 1936 Germany; stated that it was the time to speak up; noted the importance of letting food, water, and medicine in; and he asked the City Council to seriously consider a resolution.

Jeremy Bocchino, City Clerk, provided a summary of the material of record.

Council Member Vera discussed bylaws for the Bicycle and Pedestrian Advisory Committee (BPAC) with regard to membership; concern with age and residency requirements; providing a good representation of Culver City youth; and he received clarification that his concerns related to Item C-10.

Discussion ensued between staff and Council Members regarding lengthy discussion of the bylaws by the BPAC; difficulty filling the youth seat; the minimum age of 16 years old to be able to serve; average length of service; efforts to expand the pool of applicants to include West Los Angeles College students; finding a good working model to meet the needs of children in the community; concern with a lack of consistency between requirements for the business member on the BPAC and the business member on the Finance Advisory Committee (FAC); language carried over from creation of the BPAC; receiving consensus from the body regarding the amendment; City Council determination of the bylaws; concern with excluding small business owners with less than three employees; and City Council consensus was achieved from all Council Members present to make requirements for the BPAC business member consistent with those of the FAC.

Additional discussion ensued between staff and Council Members regarding lack of residency requirements for parent members; concern that CCUSD would have outsized representation with two members of a nine member body; permit students riding bicycles and public transit to get to the City; ensuring that the youth member is a student at a nearby school; BPAC recommendations; City Council control over appointments to bodies; working to be more inclusive; permit students and families that do not feel part of the community; solvency that is possible with the attendance of permit students; transition-age youth; nontraditional students; reducing barriers; difficulty getting young people to apply; differences between the FAC and the BPAC; clarification that youth are invited to participate in all bodies; curating a specific student perspective; and City Council consensus to change the title from youth to student representative, and to remove the minimum requirement of three employees for the business member from the BPAC bylaws.
