1 3. The assessment for improvements as set forth in the Engineer's Report
2 shall be performed pursuant to law. The County Auditor shall enter on the County Assessment
3 Roll the amount of the assessment and the assessment shall be collected at the same time and
4 in the same manner as the County property taxes are collected. After collection by the County,
5 the net amount of the assessment shall be paid to the City of Culver City.

6 4. Upon receipt of monies representing assessments collected by the
7 County, the City shall deposit the monies into a special fund known as the "Fund for Benefit
8 Assessment District West Washington Boulevard No. 1," which was previously established
9 upon the creation of the District.

10 5. Immediately upon the adoption of this Resolution, the City Clerk shall file
11 a certified copy of this Resolution, which includes the Engineer's Report containing the diagram
12 and assessment, with the County Auditor.

13 6. A certified copy of the Engineer's Report shall also be filed in the Office
14 of the City Engineer, with a duplicate copy on file in the Office of the City Clerk, and shall be
15 open for public inspection.

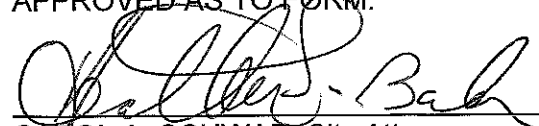

3. The assessment for improvements as set forth in the Engineer's Report shall be performed pursuant to law. The County Auditor shall enter on the County Assessment Roll the amount of the assessment and the assessment shall be collected at the same time and in the same manner as the County property taxes are collected. After collection by the County, the net amount of the assessment shall be paid to the City of Culver City.

4. Upon receipt of monies representing assessments collected by the County, the City shall deposit the monies into a special fund known as the "Fund for Benefit Assessment District West Washington Boulevard No. 1," which was previously established upon the creation of the District.

5. Immediately upon the adoption of this Resolution, the City Clerk shall file a certified copy of this Resolution, which includes the Engineer's Report containing the diagram and assessment, with the County Auditor.

6. A certified copy of the Engineer's Report shall also be filed in the Office of the City Engineer, with a duplicate copy on file in the Office of the City Clerk, and shall be open for public inspection.
