THE POSITION

This position assists in the development and implementation of treatment plans including leading activity groups and providing rehabilitation and supportive counseling. Provides mental health and substance use counseling for individuals who are experiencing a mental health emergency or substance use.

1. Develops and maintains community networks and educational programs.
2. Provides social services such as patient advocacy and placement for both prospective and current ~~patients~~ **clients**.
3. Interviews and screens prospective clients. Determines need and facilitates patient referrals to professional staff members.
4. Assists individuals or groups to recognize and correct home, family or community conditions contributing to mental health or drug/alcohol problems.
5. Helps ~~patients~~ **clients** obtain solutions to problems of employment, housing and education where these problems are disruptive to patient's mental health; makes full use of community resources to help with patient rehabilitation.
6. Establishes lines of communication between the Department of Mental Health, law enforcement and the community. Explains mental health programs to residents, and under supervision develops and implements projects designed to rehabilitate individuals who are experiencing a mental health emergency

or substance use.

7. Works with licensed professional staff in formulating and conducting mental health education programs for the general community.
8. Assists community organizers or groups in recognizing and evaluating community conditions which contribute to mental health problems and stimulate community interest in correcting these conditions.
9. Acts as an advocate for a patient that is unable to represent himself.
10. Assists licensed professional staff in assessments and treatment planning. May plan and implement specific aspects under supervision.
11. Provides input and assists in the preparation of monitoring reports and correspondence pertaining to a client.
- ~~12. Leads activity groups and co-leads individual and group rehabilitation (counseling). Conducts on-going individual and group counseling sessions for individuals who are in drug and alcohol programs.~~
13. Performs a daily safety check and routine servicing of assigned vehicles. Identifies maintenance or repair needs of assigned vehicle and reports these needs to a supervisor.
14. Transports clients in a van to various locations in a safe manner and in accordance with the California Vehicle Code, observing all safety and traffic regulations.
15. Performs other duties as assigned.

Minimum Requirements – Education and Experience:

Any combination equivalent to training and experience that could likely provide the required knowledge, skills, and abilities would be qualifying. A typical way to obtain the knowledge, skills, and abilities would be a ~~high school diploma~~ bachelor's degree ~~or equivalent~~ in psychology, social work, counseling, or related behavioral health field is required and three (3) years of experience providing mental health or related services which included interviewing and referring clients and performing crisis intervention. ~~psychology, social work, counseling, or related behavioral health field is required. A master's degree is desirable.~~

EXAMINATION PROCEDURES

Applicants must receive a passing score on all examination components for placement on the eligible list.

- **Oral Appraisal Interview (weighted at 100%):** Evaluates education, training, and personal qualifications. (Tentatively scheduled for the week of TBD).

The selection process will include the following to determine suitability for the position:

Selection Interview with the Housing & Human Services Department Background and Reference check, including Live Scan fingerprinting, Medical Examination; candidates must pass a pre-placement medical examination, which will include a drug screen. A positive pre-placement drug test, refusal or failure to test may result in rejection of the candidate.

Upon hire, employee is subject to further reporting from DOJ via subsequent arrest notification.
