RESPONSE Schrader: No exterior parking at all. Entrance will be off Lindblade only. 18 parking stalls to be provided at grade. Another 170 stalls within the three story parking structure under the building. All parking is tucked inside the building. As far as uses, the plan calls for commercial Office space. Washington height is 56 feet and Lindblade height is 43 feet.

Kim Page

- Neighbor from Higuera, who frequently utilizes the Washington sidewalk heading east
- Inquired about sidewalk closure during construction. Mentioned that the last project (not related) seemed to take years.

RESPONSE Shrader: At this time, General Contractor is not yet onboard and construction logistics to be deferred to closer to work start. A shortcut access from Lindblade directly to Washington is not feasible due to the private property it would intersect. It is unlikely the sidewalk would be closed for an extensive period for time and the goal would be to keep South Washington closure for specific days needed.
