

RESOLUTION NO. 2019-P002

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF CULVER CITY, CALIFORNIA, (1) APPROVING TENTATIVE PARCEL MAP, P2018-0279-TPM AND ADMINISTRATIVE MODIFICATION P2018-0279-AM; AND (2) RECOMMENDING TO THE CITY COUNCIL APPROVAL OF AN EXCEPTION TO CULVER CITY MUNICIPAL CODE (CCMC) CHAPTER 15.10: SUBDIVISIONS; TO ALLOW THE CONSTRUCTION AND CREATION OF TWO ATTACHED TOWNHOME STYLE RESIDENTIAL UNITS ON TWO LOTS AT 4116 HIGUERA STREET IN THE LOW DENSITY TWO FAMILY (R2) ZONE.

(TENTATIVE PARCEL MAP, P2018-0279-TPM, ADMINISTRATIVE MODIFICATION, P2018-0279-AM)

WHEREAS on November 15, 2018, F Bar and A Kendall 1997 Revocable Trust and Nicolas Kendall-Bar (the "Applicant") filed an application for Tentative Parcel Map and Administrative Modification to construct a two-story, two-unit, townhome-style residential project by creating two (2) attached townhome style dwelling units on two new lots within one existing residential lot at 4116 Higuera Street (the "Project"). The Project site is legally described as Lot 102 of Tract No. 4161 in the City of Culver City, County of Los Angeles, State of California; and,

WHEREAS, in order to implement the proposed project, approval of the following applications and other actions is required:

1. Tentative Parcel Map P2018-0279-TPM: To ensure the subdivision complies with all required standards, City ordinances and state law; to ensure lot sizes are compatible with existing lot sizes in the immediate neighborhood; to provide necessary street dedication and improvements; and to prevent interference with the opening or extension of streets for emergency vehicular access, proper traffic circulation, drainage and the future development of adjacent properties, and

- 1                   2. Administrative Modification P2018-0279-TPM: To ensure the strict application of  
2                   Municipal Code standards creates an unnecessary, involuntarily created  
3                   hardship or unreasonable regulation which makes it impractical to require  
4                   compliance with the development standards.  
5  
6                   3. Subdivision Design Standard Exception: To ensure the project meets the  
7                   criteria, set forth in Culver City Municipal Code (CCMC) Section 15.10.085 for  
8                   approving an exception to certain subdivision requirements;

9                   WHEREAS, the Project qualifies for a categorical Exemption, pursuant to CEQA  
10                  Section 15303, Class 15 – Minor Land Divisions

11                  WHEREAS on January 23, 2018, after conducting a duly noticed public hearing on  
12                  the subject application, including full consideration of the application, plans, staff report,  
13                  environmental information and all testimony presented, the Planning Commission (i) by a vote  
14                  of \_\_\_ to \_\_\_ , adopted a Categorical Exemption, in accordance with the California Environmental  
15                  Quality Act (CEQA), finding the Project will not result in significant adverse environmental  
16                  impacts; (ii) by a vote of \_\_\_ to \_\_\_ , conditionally approved Tentative Parcel Map P2018-0279-  
17                  TPM (subject to City Council approval of an exception to certain required subdivision design  
18                  standards) and Administrative Modification P2018-0279-AM, as set forth herein below; and (iii)  
19                  by a vote of \_\_\_ to \_\_\_ , recommended to the City Council approval, pursuant to CCMC Section  
20                  15.10.085, of an exception to a subdivision design standard requiring lot frontage along a  
21                  dedicated public street or access to same via a certain sized “stem” of a “flag lot” (CCMC  
22                  15.10.700.C), as set forth hererin below..  
23

24                  NOW, THEREFORE, THE PLANNING COMMISSION OF THE CITY OF  
25                  CULVER CITY, CALIFORNIA, RESOLVES AS FOLLOWS:  
26  
27  
28  
29

1                   **SECTION 1.** Pursuant to the foregoing recitations and the provisions of the CCMC,  
2                   the following required findings are hereby made:

3                   **Tentative Parcel Map**

4                   As outlined in CCMC Section 15.10.630, the following required findings for a Tentative Parcel  
5                   Map are hereby made:

6                   **A. The proposed division will not be materially detrimental to the public welfare nor**  
7                   **injurious to the property or improvements in the immediate vicinity.**

8                   The proposed division will create two small lots for two attached townhome style dwelling  
9                   units within one land lot allowing separate ownership opportunities of the units. Per  
10                  Section 17.210.020 – Table 2-3, Residential District Development Standards (R1, R2,  
11                  R3), the R2 Zone permits up to two units to be developed on the subject property.  
12                  Accordingly, the subdivision component of the Project will not increase the number of  
13                  units allowed on the site, or cause any physical changes to the surrounding lots of similar  
14                  zoning and density potential and, therefore, is not expected to have any detrimental  
15                  impacts to the public welfare or to property or improvements in the vicinity. The dwelling  
16                  units will comply with all applicable provisions of the Zoning Code and is permitted in  
17                  the R2 Zone.

18                  **B. The proposed division will not be contrary to any official plan adopted by the**  
19                  **Council of the City of Culver City or to any policies or standards adopted by the**  
20                  **Commission or the Council and on file in the office of the City Clerk at or prior to**  
21                  **the time of filing of the application hereunder.**

22                  The proposed subdivision is in compliance with the policies and standards of the City  
23                  including the City's General Plan. The Public Works Department has also reviewed the  
24                  the following required findings are hereby made:

1 Tentative Parcel Map and determined it will not be contrary to any adopted public  
2 improvement plans. There is no overlay or Specific Plan designated for this area, and  
3 the proposed subdivision will not conflict with other adopted plans.

4 **C. Each proposed lot conforms in area and dimension to the provisions of the**  
5 **Zoning Code requirements, as set forth in Title 17 of this Code.**

6 CCMC Section 17.210.020 requires minimum lot dimensions of fifty (50) feet in width  
7 and 100 feet in depth, and a minimum lot area of 5,000 square feet or the average area  
8 of residential lots within a 500-foot radius of the proposed subdivision, whichever is  
9 greater, and further notes condominium, townhome, or planned development projects  
10 may be subdivided with smaller parcel sizes for ownership purposes, with a minimum  
11 lot area determined through the subdivision review process, provided that the overall  
12 development site complies with the minimum lot size requirements of this chapter. The  
13 Project Site measures 45 feet in width by 120.82 feet in depth for a total of 5,436 square  
14 feet, which is slightly smaller than other lots in the neighborhood. Within this standard  
15 lot, two smaller parcels will be created for two townhome style units, which is permitted  
16 as noted above. Thus, the project site conforms to the provisions of the Zoning Code.  
17 In addition, review of the tentative parcel map by the Public Works Division has found  
18 the map in substantial conformance with the City's requirements.

19 **D. Each lot in the proposed division will front on a dedicated street or have a**  
20 **vehicular access to a dedicated street approved by the City.**

21 The proposed development has vehicular access by means of a driveway apron directly  
22 adjacent to Higuera Street which is an existing public right-of-way abutting the southern  
23 (front) property line. The individual lots, corresponding dwelling units, and assigned  
24  
25  
26  
27  
28  
29

1 parking areas within the site, will be accessed by means of a sixteen (16) foot wide  
2 driveway on the west side of the property with a property line down the center and  
3 easements for access purposes . The project Site provides adequate on-site circulation  
4 and parking, in compliance with the Zoning Code.

5 CCMC Section 17.10.700.C, requires that all lots front on a dedicated public street or  
6 have access to the same via a private street or the “stem” of a “flag lot”. Flag lots shall  
7 be allowed only when, in the opinion of the Planning Commission, there is no reasonable  
8 alternative. The Project site is only 45 feet wide fronting Higuera Street and the Project’s  
9 rear lot can only be accessed from said dedicated public street with a flag or stem. While  
10 the applicant is proposing a stem lot, it is not reasonable nor physically possible to  
11 require a 50 foot frontage for the rear lot nor a ten foot wide driveway for each unit. This  
12 lot, as discussed above, will have access via easements for common use driveway and  
13 pedestrian purposes. Further an exception to the minimum stem or flag width can  
14 reasonably be granted and is discussed below in the Subdivision Design Standard  
15 Exception finding.

16  
17  
18  
19 **E. Each lot in the proposed division is so designed and arranged that drainage to an**  
20 **approved drainage facility is provided for each lot.**

21 Following review of the Tentative Parcel Map by the Public Works Department, it has  
22 been conditioned that the applicant submit a Site Improvement Plan which shall include  
23 detailed on-site drainage and grading of the site indicated by topographical lines and  
24 spot elevations. Said plan will be required to meet the requirements of this finding.  
25 Further, the proposed division is for townhome style lots within the project lot with  
26 secured appropriate easements allowing drainage across the individual lots within the  
27  
28  
29

1 project lot and is designed such that the drainage is not impeded. The conditions of  
2 approval will ensure the proposed project will be in conformance with this required  
3 finding prior to any final approval of the proposed division.

4 **F. The proposed division will not interfere with the widening, extension, or opening**  
5 **of any street or Master Plan highway.**

6 Located within an existing urbanized residential neighborhood, the proposed division is  
7 provided access by means of the existing public right-of-way, Higuera Street. Following  
8 Public Works review of the Tentative Parcel Map, it was found that there is no  
9 requirement to widen Higuera Street. Further, there were no items of potential  
10 interference identified between the proposed division and any known street Master Plan  
11 highway.  
12

13  
14 **G. Lot lines are so designed that easements will be located in such positions as to**  
15 **be suitable for the proposed use.**

16 The existing parcel is currently developed with a single family dwelling and has  
17 easements located to provide various utilities to the site. The proposed subdivision will  
18 not encroach into or interfere with these existing elements. Further, the site layout is  
19 designed such that the proposed lots and associated dwelling units are located to allow  
20 access and open space where future required easements may be adequately placed.  
21  
22

23 **Administrative Modification**

24 As outlined in CCMC Section 17.550.020, the following required findings for an Administrative  
25 Modification are hereby made:

26 **A. The strict application of the applicable development standard creates an**  
27 **unnecessary, involuntarily created hardship or unreasonable regulation which**  
28  
29

1 makes it obviously impractical to require compliance with the development  
2 standards.

3 The 45 foot width of the lot restricts the ability to provide a typical side loaded garage  
4 and meet all applicable standards for interior dimensions, setback, and turning radius.  
5 The front loaded garage with reduced backup length and parking space length will  
6 preserve landscaping in the front yard to reduce prevalence of parking along the public  
7 right-of-way consistent with multi-family design guidelines.  
8

9 **B. Approval of the Administrative Modification would not be detrimental to the public**  
10 **health, interest, safety, or general welfare and would not be detrimental or**  
11 **injurious to property or improvements in the vicinity and in the same zoning**  
12 **district.**

13  
14 The Administrative Modification will help to reduce prevalence of parking along the  
15 public right-of-way. Four parking spaces will still be provided and only two uncovered  
16 spaces will be reduced in length by ten percent. All parking spaces will still have  
17 unimpeded access from the public right-of-way into the property.  
18

19 **C. The project is consistent with the General Plan and complies with all other**  
20 **applicable provisions of this Title.**

21 The project is consistent with the General Plan and Zoning Code per all previous  
22 evidence provided per the Resolution and as referenced by the Staff Report.  
23

24 **Subdivision Design Standard Exception**

25 As outlined in CCMC Section 15.10.085, the following findings for an exception to subdivision  
26 requirements are hereby made:  
27  
28  
29

1       **A. The conditions affecting the property warrant and require that an exception be**  
2       **made.**

3       The Zoning Code requires a minimum lot area of 5,000 square feet, or the average area  
4       of residential lots within a 500-foot radius of a proposed subdivision, and further states  
5       that condominium, townhome, or planned development projects may be subdivided with  
6       smaller parcel sizes for ownership purposes, with the minimum lot area determined  
7       through the subdivision review process. The overall project will maintain its current  
8       5,436 square foot lot area. The overall 45 foot lot width will not change and the overall  
9       120.82 foot lot width will not change. Through the subdivision processes, two small land  
10      lots for townhome style development will be created within the existing conforming lot.

11      CCMC Section 15.10.700 sets forth general design standards governing the approval  
12      of any subdivision map. Specifically, CCMC Section 15.10.700.C, requires that all lots  
13      front on a dedicated public street or have access to the same via a private street or the  
14      “stem” of a “flag lot”. Flag lots shall be allowed only when, in the opinion of the Planning  
15      Commission, there is no reasonable alternative. The Project’s rear lot will have a stem  
16      that touches the public right-of-way, but the project cannot accommodate the City  
17      Subdivision standard minimum of a ten foot wide driveway per stem per CCMC Section  
18      15.10.700.C. The project is providing a 16 foot wide driveway easement split between  
19      both lots on which the dwellings will be located, similar to a standard condominium or  
20      townhome development. The Project is consistent in design and function with  
21      condominium and townhome developments. The key difference is that each resident  
22      will own the dwelling as well as the land around it as opposed to each resident owning  
23      the land around the dwellings in common. The 45 foot lot width does not allow for two  
24      25  
26  
27  
28  
29



1 ten foot wide stems because the driveway would be 20 feet diminishing the ability to  
2 provide a viable living space.

3 For these reasons, the conditions affecting the property warrant and require that an  
4 exception be made to the requirement for public street frontage and the minimum stem  
5 size required for access to the public street via a flag lot.  
6

7 **B. The exception is not an exception to any requirement of the Subdivision Map Act.**

8 The exception does not violate the Subdivision Map Act because a 16 foot wide  
9 easement for common driveway purposes is provided assuring the public right-of-way  
10 access for both lots within the development.  
11

12 **C. The exception will not be materially detrimental to the public welfare nor injurious**  
13 **to the property or improvements in the immediate vicinity.**

14 All required subdivision findings can be made for the Project and all required vehicular,  
15 pedestrian, and utility/drainage easements will be made a part of the final map assuring  
16 both lots have required access to public rights-of-way. The exception will not be  
17 materially detrimental to the public welfare nor injurious to the property or improvements  
18 in the immediate vicinity.  
19

20 **SECTION 2.** Pursuant to the foregoing recitation and findings, the Planning  
21 Commission of the City of Culver City, California, hereby (i) adopts a Categorical  
22 Exemption in accordance with the California Environmental Quality Act (CEQA), finding  
23 the Project will not result in significant adverse environmental impacts; (ii) approves  
24 Tentative Parcel Map, P2018-0279-TPM (subject to City Council's approval of an  
25 exception to certain required subdivision design standards) and Administrative  
26 Modification P2018-0279-AM; and (iii) recommends to the City Council approval of an  
27  
28  
29

1 exception to a subdivision design standard requiring lot frontage along a dedicated  
2 public street or access to the same via a certain sized “stem” of a “flag lot” (CCMC  
3 Section 15.10.700.C), subject to the conditions of approval set forth in Exhibit A  
4 attached hereto and incorporated herein by this reference.
