2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 CULVER CITY, CALIFORNIA, AUTHORIZING THE CITY
4 ATTORNEY TO APPROVE SETTLEMENTS FOR WORKERS
5 COMPENSATION CLAIMS AND SETTING A LIMIT THEREON,
6 AND RESCINDING RESOLUTION
7 NO CS-7846

8 WHEREAS the City is self-insured for its workers' compensation liability, and

9 WHEREAS Resolution No CS-7846 adopted in 1979 conferred authority for
10 settlement of workers' compensation claims on the Chief Administrative Officer or
11 his/her designee and

12 WHEREAS, since 1979 it has been the custom and practice that workers'
13 compensation claims settlement has been delegated to the City Attorney in
14 consultation with the Risk Manager, and

15 WHEREAS, the City Council has determined that the City Attorney should be
16 authorized to approve settlements for workers' compensation claims up to \$100 000 in
17 consultation with the Risk Manager with cases over that amount being referred to the
18 City Council for review and approval

19 NOW THEREFORE the City Council of the City of Culver City California
20 DOES HEREBY RESOLVE as follows

21 SECTION 1 The City Attorney is hereby authorized to settle
22 workers compensation claims up to \$100,000 with cases over that amount being
23 referred to the City Council for further review and approval


