RESOLUTION NO. 2015-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA, APPROVING THE TEMPORARY CLOSING OF PORTIONS OF WASHINGTON BOULEVARD, WASHINGTON PLACE AND CENTINELA AVENUE IN CONNECTION WITH THE CICLAVIA CULVER CITY EVENT, A CITY SPONSORED EVENT, TO BE HELD ON AUGUST 9, 2015 AND ADOPTING RELATED RULES AND REGULATIONS.

WHEREAS, Section 21101(e) of the California Vehicle Code provides local authorities, for those highways under their jurisdiction, may adopt rules and regulations by ordinance or resolution on certain matters, including temporarily closing a portion of any street for celebrations, parades, local special events, and other purposes when, in the opinion of local authorities having jurisdiction or a public officer or employee that the local authority designates by resolution, the closing is necessary for the safety and protection of persons who are to use that portion of the street during the temporary closing; and,

WHEREAS, during the Regular Meeting of the City Council held on March 10, 2014, the City Council adopted Resolution 2014-R003 which approved a joint application with the City of Los Angeles and CicLAvia for grant funds through Los Angeles County Metropolitan Transportation Authority's (Metro) Open Streets Program for the CicLAvia Culver City event (2015 CicLAvia); and,

WHEREAS, on July 3, 2014, the City received notification from Metro that the joint application was approved; and,

WHEREAS, during the Regular Meeting of the City Council held on June 22, 2015, the City Council approved City sponsorship of the 2015 CicLAvia; and,

WHEREAS, during the Regular Meeting of the Committee on Permits and Licenses (Committee) held on July 22, 2015, the Committee approved a permit application submitted by CicLAvia for the 2015 CicLAvia, subject to the City Council's approval of the related street closures for the 2015 CicLAvia; and,

WHEREAS, the temporary closing of portions of Washington Boulevard, Washington Place and Centinela Avenue (collectively "Subject Streets") is necessary for the safety and protection of the persons who are to use those portions of the Subject Streets during the temporary closing for the 2015 CicLAvia.

NOW, THEREFORE, the City Council of the City of Culver City, DOES HEREBY RESOLVE AS FOLLOWS:

- The City Council hereby approves the temporary closing of the Subject Streets in connection with the 2015 CicLAvia.
- 2. The City Council hereby finds and determines that the closing of the Subject Streets is necessary for the safety and protection of persons who are to use those portions of the Subject Streets during the temporary closing for the 2015 CicLAvia.
- 3. The rules and regulations applicable to the closure of the Subject Streets for the 2015 CicLAvia shall be those set forth in the Permit approved by the Committee on July 22, 2015.

1	3. Further, the City Manager, Police Chief, and Director of Public
2	Works/City Engineer or their duly authorized designees are hereby designated to
3	impose additional rules and regulations as they may deem appropriate for the safety
4	and protection of persons who are to use those portions of the Subject Streets during
5	the temporary closing for the 2015 CicLAvia.
