Item P-1

Presentation by NOW Art

Sam Lee, Cultural Affairs Analyst, introduced Carmen Zella, founder of NOW Art, and Claudia Oliveira.

Carmen Zella and Claudia Oliveira, NOW Art, congratulated the new Chair; provided a presentation on Attune LA; discussed the multi-disciplinary project using sound frequencies positioned throughout Los Angeles County; the light component; the goal to create a sense of unity; the power of the collective experience; sites selected to unify the City; sound being played at the same time at all locations; the artist chosen for the project; selected sites; reuse of the platform; fostering the locations as known gathering sites; equity; the opportunity to test connectivity technology before larger events; wheelchair accessibility; the free events; micro-sites; welcoming other cultural or health and healing organizations; branding of the locations; providing autonomy and ownership of the events; the current Board of Advisors; the proposed program; she provided background on the organization; discussed grants; public/private sponsorships; and requested support and partnership with Culver City.

Discussion ensued between NOW Art representatives, staff, and Commissioners regarding appreciation for the presentation; post production; the intent not to have visual components in order to encourage people to go inside; documentation with a videographer; the potential to livestream; the need to agendize the item to have a full conversation; limited time to do the event in 2025; permits; exploration of collaboration with the Culver City Artist Laureate; commitments to date; community impact; the importance of the scale of the event; conversations about potential locations; City Council consideration; remanding the matter to the Public Art Subcommittee; logistics; continued discussion; weather considerations; expediting the project; and unanimous consensus of Commissioners present was received to place consideration of the project on an agenda in the future.

Sam Lee, Cultural Affairs Analyst, reported that Sonia Romero's tiled installation "The Speedway" had been installed at the Farragut Connector noting the plaque has been ordered; he thanked Hope Parrish for help ensuring that information on the plaque was historically accurate.

Lee Lawlor, Cultural Affairs Analyst, announced upcoming grant sponsored performances and indicated that information about all events was posted on the City website.

Sally Unsworth, Cultural Affairs Manager, discussed upcoming items of interest for the Commission including the Visit Culver City event on July 16, 2025; indicated being part of the selection committee for the firm retained; reminded everyone of Fiesta La Ballona from August 22-24; discussed the unveiling of Sonia Romero's work at the Farragut Connector on August 24; Meetup in August to introduce area artists to Artist Laureate

Victoria Marks; meet and greet events; the Arts Foundation Booth at Art Walk and Roll in the Arts District on October 18; the work plan presentation to the Commission in October; the Summer Concert series; the pre-program hosted by the Culver Arts Foundation; a Q&A session hosted by Victoria Marks at the final concert for 2025 on August 28 as part of her introduction to the community; Music in the Chambers on September 7, 2025; the next Creative Economy event planned for October 16, 2025; the recent retreat with Economic Development and Cultural Development; the activation planned with the Cultural Plan; obtaining stakeholder feedback; and she thanked City Historian, Hope Parrish and Hackman Capital for working with the City on an upcoming event about the history of moving the bungalows for Culver Studios in fulfillment of the public-facing program requirement for Hackman Capital.

Commissioner Gupta was excited to hear about all the upcoming events.

Commissioner Fleischer reported attending Victoria Marks' performance at the Odyssey Theater, the Reservoir at The Geffen, and the Culver City Symphony Orchestra concert; she was looking forward to the Summer Concert series and read the schedule of performers; announced upcoming Actors' Gang shows; and she indicated being excited to attend the Visit Culver City meeting noting the importance of cultural tourism.

Chair O'Carroll thanked Hope Parrish for her help; expressed appreciation to Edgar Varela for Summer Concert series; discussed the upcoming Visit Culver City meeting; and expressed excitement about the prospect of a Visit Culver City website.
