A total of twenty minutes shall be devoted to audience participation at the beginning of the agenda. Speakers will be called on in the order cards were received by the Commission Secretary. If additional time is needed, the Chair will allow for same at the end of the agenda.

A three-minute limit may be declared by the Chair if there are a large number of individuals desiring to address the Commission.
