# Community Announcements by Members/Updates from Commissions, Boards and/or Committees/Information Items from Staff

Council Member Puza reported attending events at the Mosque for Ramadan with the Mayor and Vice Mayor; announced the Spring Eggstravaganza at Veterans Memorial Park on March 23; and he discussed the City's release of an Accessory Dwelling Handbook with pre-approved plans for residents considering ADUs (Accessory Dwelling Units) on their property with more information on the City website.

Vice Mayor O'Brien announced meetings in Council Chambers on March 18-19 at 3:00 p.m. to consider the budget for the coming fiscal year and a community meeting with the Culver City Police Department (CCPD) on April 4 regarding RIPA (Racial and Identity Profiling Act) data from the past year.

Mayor McMorrin discussed the 12<sup>th</sup> Anniversary Walk 'n Rollers event over the past weekend; reported attending Breaking Barriers Building Bridges: The Journey to Shatter the Glass Ceiling in Honor of Women's History Month at Getty House on March 17; thanked the Equity and Human Relations Advisory Committee (EHRAC) for their efforts to put together the Cityhosted Courageous Conversation on March 19 at Veterans Memorial Building; discussed Disability Awareness Month in March; Persian New Year on March 19; and she thanked Culver CityBus for their work noting that March 18 is Transit Operator Appreciation Day.

# Presentation from the Culver City Fire Chief Regarding Accreditation-Related Documents and Insurance Services Office (ISO) Class Rating

Ken Powell, Fire Chief, provided an update on the completion of Fire Department documents and achievements; discussed the community-driven Strategic Plan for 2024-2029; internal and external stakeholders; goals and objectives; established benchmarks; identification of performance gaps; ensuring a safe and effective response; Community Risk Assessment; the Class 1 ISO Rating for Culver City since 1995; and he noted that additional information was available on the Culver City Fire Department (CCFD) website.

Discussion ensued between staff and Council Members regarding status of the surrounding fire departments; cities that do not engage in the accreditation process; the ISO rating process; and appreciation to staff for their efforts to maintain the quality of CCFD.

#### Joint Public Comment - Items NOT On the Agenda

Mayor McMorrin invited public comment.

The following members of the public addressed the City Council:

Emily Sarvinski thanked Culver City for their partnership on Taste of the Nation at Media Park; provided an overview of No Kid Hungry; discussed goals; the premise that it takes more than food to solve hunger; food insecurity; helping communities create and improve meal programs for kids; grant funding; advocating for laws and policies that help families feed their children; national campaigns working on a local level; raising awareness and funds to support the work to combat hunger; and she asked for support for the May 4 event.

Jeremy Bocchino, City Clerk, read the City statement regarding hate speech.

Mary Daval discussed AB1909; the requirement that motor vehicles must move over one lane when passing bicyclists instead of only allowing a distance of three feet; sharrows; different scenarios for different streets; bike lanes; the door zone; and she indicated that giving space to cyclists is not just a courtesy, it is the law.

Melissa Stucky asserted that Culver City had been infiltrated by progressives from outside the City who wanted to continue to ruin their small town; indicated that she would stand up to the corruption that is being voted on in the City Council; discussed lack of transparency in hiding changes to City policy in agendas; not addressing votes until five hours into the meeting; voting against people whose health will be affected by allowing 5G radiation right next to their windows; lack of care for constituents; she proposed putting cell towers next to where Council Members sleep; discussed making changes to restroom policy rather than spending money to add restrooms or safe changing spaces; allowing people to enter other people's safe space; trendy and divisive agenda items to get money and votes; and she felt that Culver City was self-destructing.

Marci Baun discussed an experience a friend had showering at the El Segundo Aquatics Center; provided statistics regarding rape and sexual harassment; expressed concern with pedophiles and sexual predators who will take advantage of rules meant to help transgender individuals; discussed those who have been intimidated by others physically; concern with disappearing safe spaces for women; reported being sexually assaulted four times; indicated that she felt separate facilities should be provided; and she asked the City Council to re-think their decision.

Daniela V. was called to speak but was not present in Council Chambers or online.

Maria Carrilla discussed the motion to revise restrooms in parks, public buildings, and city properties; lack of public outreach; overuse of the term inclusion and diversity; the need to protect children; celebrating Women's History Month; keeping women and children in the community safe; and she asked that the City Council reconsider their decision.

James Richardson was called to speak but was not present online or in Council Chambers.

CC - (1) Consideration of a Request from the Asian World Film Festival to Rename Portion of "A Street" to Bruce Lee Alley

# Pursuant to City Council Policy 3403; and (2) Direction to the City Manager as Deemed Appropriate

Elaine Gerety-Warner, Economic Development Manager, provided a summary of the material of record.

Discussion ensued between staff and Council Members regarding requirements to meet all criteria, and clarification that the section is now called A Street.

Mayor McMorrin invited public comment.

The following members of the public addressed the City Council:

Andy Cheng reported discussions with the Bruce Lee Foundation and with Bruce Lee's daughter; discussed buying the house Bruce Lee lived in when he was young;; renaming the street or the alley; the inability of the house to serve as a museum; placement of a statue; the Asian World Film Festival; policy; petition signatures; culture; storytelling; educating the younger generation; costs; he requested help navigating difficult policy with an exemption; and he asked whether the City felt it would be possible to move forward.

Eileen Chen discussed diversity in the City and appreciation for City support of the Asian World Film Festival over the past ten years; Bruce Lee's philosophy of people growing together; and she indicated that the Bruce Lee Foundation supported the idea and would come to make a pitch if the City wanted to move forward.

Andy Cheng indicated that the statue had been created and they needed a location for it; discussed their dream and the dream of Bruce Lee; and creating a landmark with Bruce Lee's former home.

Karim Sahli expressed support of the idea; recommended changing the name of the alley and of Irving to Bruce Lee Street as well as creating a zoning exemption to turn the house into a little museum; noted the potential for a large amount of money brought in by the museum; discussed Bruce Lee's legacy; Foundation support of the project; he felt it would be foolish not to encourage the project; and noted the importance of allowing the project to grow into a beneficial addition to the legacy of the City.

Discussion ensued between staff and Council Members regarding creation of the new standards for recognitions; concern with sidestepping the process; other famous figures who have lived in Culver City or people who have made an impact; the fact that Bruce Lee lived in Culver City for one year; limited spaces that can be named; the Bruce Lee Museum in Seattle where he is buried; finding another path of recognition; acknowledgement of the legacy of Bruce Lee; Culver City sponsorship of the Asian World Film Festival; appreciation for the tenacity and drive of the organizers; support for the philosophy; respect for the process; openness to making an exception; the fact that the street is not already named; ensuring that all promotional materials include Culver City; the need for more support to move forward and a suggestion to seek support through mailers, local Asian organizations, martial arts groups, film societies, and the Historical Society; naming of a square or a corner; the inability for the organization to meet the naming criteria; opening the door for other organizations to apply for the same thing; the pass-through area; recognizing other cinema greats with statues; creating a draw for the City; concern with having a museum in a residential area; existing parking issues on the street; lack of consensus for a renaming; consensus to see if there is any interest in exploring another path of recognition; doing something similar to what was done to honor Judge Cherness with a plaque; placement of a plaque on park benches in the paseo; ensuring against creating too much variance in the ordinance; staff agreement to return with ideas; the new Cultural Affairs Manager; clarification that naming a corner is a level III recognition that has its own criteria, plaques are a Level II, and name plates are a Level I; consensus to direct staff to return with options and to consult the Historical Society; and City Council consensus to direct staff to come up ideas for something creative to honor significant individuals in the entertainment industry.

Andrew Goodrich, Architectural Resources Group (ARG), provided an overview of the Historical Context Study; discussed the purpose of the study; methods; primary and secondary source search; outreach; the dedicated webpage; the online public comment form; the importance of hearing from people; and organization of the study.

Discussion ensued between Mr. Goodrich, staff, and Council Members regarding studies of other cities conducted by ARG; efforts in Culver City that were not done in other cities to turn racist policy around in the late 1960s; appreciation for the report; ensuring that enough time had passed to understand what was going on; firm data through 2010; adding data from the 2020 census if the City Council desired; the effort to create a historical study; efforts of the Equity Subcommittee to get people to participate; the study commissioned by Culver City in 1968 and the Human Relations Commission established at that time to ensure that Culver City was working to overcome past practices of discrimination and promote inclusion; neighborhood associations and fair housing councils run by citizens that helped People of Color navigate unfair housing practices and paved the way for integrating Culver City neighborhoods; specificity with names and details included in earlier parts of the City's history; lack of unanimity in the decision to apologize for the racist past of Culver City; and whether it was a conscious decision not to include names and details of the more recent history in the City.

Additional discussion ensued between staff and Council Members regarding internal discussion about names included throughout the report; public information; the decision made to suppress names to foster more powerful and impactful change in the future; development of the Racial Equity Action Plan (REAP); the context study as a first and significant step in examining public policy that needs to be addressed rather than focusing on the names; centering issues to move forward; and the iteration of the report that does not have redacted information.

Mayor McMorrin invited public comment.

The following members of the public addressed the City Council:

Karim Sahli was shocked that the authoritative document suppressed names and voting records; he wanted to see the basics on where to find the information; discussed lack of information on the vote for a racial apology; the pretext that information was left out in order to move forward; he wanted to see the non-redacted version of the document; he felt that in order to move forward it was important to know who did what and their intention at the time; he expressed concern about the ability of the next generation to get the information; and he asked that the redacted version be released.

Discussion ensued between staff and Council Members regarding the first vote moved by Council Members Eriksson and Vera to adopt the Glendale resolution that was more inclusive and did not include reparations as an issue; appreciation to staff and ARG for the study and to the prior City Council who supported the resolution to acknowledge the history of the City; the importance of acknowledging the truth of the past in order to move forward and of telling the accurate truth rather than the whitewashed version; people trying to tell different versions of history; disagreements and confusion about what happened in the past; understanding the segregation and discrimination to multiple communities that shaped Culver City today; remnants of discrimination that still remain; undeniable progress made; the need to show leadership to address issues; balancing tensions; holding contradictory things at the same time; the need to do things differently in order to not keep repeating the same mistakes; dismantling the outdated system; collectively making a new system that allows everyone to be included and thrive; the potential for reconciliation and change; looking back at the present time in 100 years; taking responsibility for our past and future; incorporation of the study into the reparations study and the REAP; the living document; investigation into when Fox Hills was annexed into Culver City and whether students were allowed to attend schools via permit; neighbors in the past who wanted to ban Black people from playing basketball as it was deemed too noisy and recent issues with neighbors wanting to ban the playing of soccer in a Culver City park; a request to update the reference to the amended Use of Force policy in the third paragraph, second sentence on page 62 of the report to make it factually correct; the update of the policy in 2023; and SB50.

Additional discussion ensued between staff and Council Members regarding the conclusion of the report; progress made; response from disenfranchised groups; efforts made in the 1960s to make positive change; the need to tell the entire story, not just part of it; support for the apology letter; inclusivity; the Glendale resolution; the resolution made by Culver City in the 1960s; moving forward with the REAP; non-linear growth; the positive direction that things are going in; the ability to find

the redacted information by looking in the footnotes of the report; and efforts made to grow and include all people.

Further discussion ensued between staff and Council Members regarding acknowledgement that Mayor McMorrin was the first Black woman to become Mayor in 2023; systemic and cultural barriers informing who has opportunity, who is invited into a space, and who is taken seriously; what the portraits of former mayors hanging in Council Chambers communicate to the community; internalized messages; the importance of having a historical accounting of what has happened; the principle of Sankofa, learning from the past to know where we are going in the future; timeliness of the reparations conversation; the detailed report written by the Reparations Task Force; the act of making amends; reparations for across the state; discrimination; looking at what is included or not included in the reports; policies, programs, employment, and services contributing to less favorable outcomes for minority groups; inclusion of Culver City in the following books: The Color of Law and The Sundown Towns; the importance of highlighting racial terror that was a part of maintaining Sundown Towns; complicity and overall acceptance of the violence; the Equal justice Initiative; the importance of knowing and understanding the complicated history of the country in order to move forward; recognizing Dr. Daniel Lee, the first Black man elected in the City; the need for continued work; creating a pipeline of champions who ensure that everyone can be seen; clarification that anyone can be committed to equity and fairness; the significance of the report; more firsts that will happen; new leadership needed in the community; power and privilege; the importance of questioning who is being centered by certain decisions and choices; looking at who benefits and where the power is; concern with the decision to not include certain information; who benefits from the silencing; how hiding the truth benefits neighbors; disappointment in the choice made to not tell the full story in the historical context study; and placing the burden on people to look at the footnotes and find out more about the historical context.

Additional discussion ensued between staff and Council Members regarding clarification that personal names were redacted, not events; availability of the report on the Equity page on the Culver City website; whether it is possible to vote to accept the full report without names being redacted; concern with people living in Culver City being burdened with the actions of their family members; the fact that even if things are not talked about, they still exist; former presidents who owned

other human beings; disproportionate health and wealth outcomes; the California Reparations Task Force; impacts of slavery to future generations; the culture at the time; the need to acknowledge the difficult history; being honest about how things got the way they are; complicity; the ease with which groups were harmed and marginalized; letting things happen to others because people were benefitting; targeted harms; the importance of being honest about the past; opening the door for history to repeat itself; concern with consciously skipping over the lack of acknowledgement; the relevant document describing American history taught in school on a local level; unintended consequences with including names in the document; and next steps.

CC - (1) Discussion of Options to Pave Unpaved Alleyways Citywide as Recommended by the Mobility, Parking & Traffic Subcommittee; and (2) Direction to the City Manager as Deemed Appropriate

Yanni Demitri, Public Works Director, provided a summary of the material of record.

Mate Gaspar, Engineering Services Manager, discussed subcommittee meetings; recommendations; alleys with the most amount of complaints; a product used 8 years ago to harden the soil that worked for several years; flooding; drought; complaints; funding unavailable to pave alleys; and the recent paving of a commercial alley in concrete west of Sepulveda Boulevard and the 405 freeway offramp to where Swiss Motors is located.

Discussion ensued between staff and Council Members regarding the inability of the City Council to appropriate any funds at the current meeting; money allocated in the Capital Improvement budget for street resurfacing improvement; a suggestion to include traffic volume when considering rankings; the Pavement Condition Index (PCI); and consideration of alleys adjacent to schools.

Mayor McMorrin invited public input.

The following members of the public addressed the City Council:

Jay Garacochea introduced his neighbors from Globe Avenue; thanked the City Council for their consideration; discussed the staff report; options presented; apartment owners; rent control laws; homeowners; cost to pave the alley; proposed tax increases to property owners to fund the project; different scenarios for funding the project; and current costs paid by the City to maintain the alley rather than fix it.

Mike LaGuardia discussed what happens to the alley each year after the first heavy rain; water pumped out of the alley; bandaids used by the City that created the problem; he presented photographs of asphalt under the dirt; he felt that the residents should not have to pay to fix the problem; discussed differences in elevation between the alley and the properties; properties that flood when it rains heavily; money spent to regrade areas; walls and fences; a suggestion to grade the alley to its original height; bad decisions made by a City official decades ago; lack of access to the alley from Globe; alley dust levels; health risks for residents; glue used in the alley; and he asked that the City repave the alley and come up with a comprehensive program to pave all the alleys over ten years.

Mariano Andre provided background on himself; indicated that he did not park in his garage as he might not be able to get out to go to his job; he expressed support for the City; discussed living in unhealthy conditions; pools of standing water in the alley; the plastic substance dropped in the alley by the City that worsened conditions; and he asked the City to please fix the alley properly so he could park in his garage.

Karim Sahli indicated that if the City Council decides to move forward, the new infrastructure needed to be stronger to accommodate electric vehicles and to be able to cope with the heavier rain; he discussed maintaining water in the aquifer; looking at the budget to identify funding to address the issue; and the need to increase the budget for Public Works.

Discussion ensued between staff and Council Members regarding people living on a fixed income; the subcommittee recommended split of costs for the project; inaction by the City on a problem that needs to be addressed; costs for yearly maintenance; acknowledgement that the City cannot afford to foot the bill; a suggestion for a 50/50 split between the City and residents to repave the alley; extending the period to pay off the project; standing water; diseases caused by mosquitos; petition requirements; landowners vs. residents; policy vs. law; costs imposed on owners; people who do not have a voice in the process; the Capital Improvement Project (CIP) with a lifetime of 20 years; average length of ownership; participation of multiple owners in repayment; use of a two-track system; moving those who want to participate in an assessment district forward in the process; finding a more equitable distribution of costs; providing an equity framework; support for involved neighbors; determining how resources are allocated; the need for independent assessment for sharing community resources; climate issues; investment in car infrastructure and dependence on cars; comparable investment in other neighborhoods; adding to property values with infrastructure improvements; average home value in Culver City; and support for the subcommittee suggestion for the 10/90 split at market interest rates.

Additional discussion ensued between staff and Council Members regarding increased expenditures for homeless issues; competing interests; determining where to put money; impacts to reserves; cashflow; balancing the budget; selling property and allocating revenue; property owner participation; increased costs with the school bond; those who are house-rich but cash-poor; the need for matching by owners; responsibility of the City to maintain the alleys; appreciation to Public Works for their quick response to flooding; participation by the property owners as their properties are being improved; City priorities; allowing for a community decision for the Retting property; reassessing criteria for alley repaving; determining the split between the City and residents; a suggestion to put alleys into the work plan discussion; consensus regarding extending the repayment term; next steps; the need to assess competing interests; difficulty determining annual cost; determining the percentage the City is going to cover; an observation that the larger the amount of participation required of the property owners, the slower the pace of the projects; the number of assessment districts set up; the fact that there will be no extra money

available for alley projects; funding that would have to come out of reserves or another capital improvement will not be done; grants for regular street paving; annual SB1 funding; small CalRecycle grants; Inflation Reduction Act funding for public infrastructure; Council direction to change the status quo; the decision regarding cost sharing; paving the identified alleys by reallocating funding from other planned projects; concern with requiring residents to fund 90% of the project; determining which capital project to skip in order to do the alley or taking money from the reserves; clarification that money for patching comes out of the maintenance budget; using money from street paving allocation; patching potholes rather than repaving; support from Vice Mayor O'Brien and Council Members Eriksson and Vera for a 50/50 split with an extended term for repayment; prioritization by the order signatures are consideration during the budget process; concern with the firstcome first-served process as perpetuating a system of inequity; the limited impact of the repaving of alleys on the wider community for the amount of resources used for the projects; developing a framework for equitable allocation and distribution and level of impact; resources work of the Subcommittee; collaboration with staff and the community; ensuring everyone has an opportunity to be in partnership with the City; ensuring fairness and consciousness of the impact of decisions; and the fact that decisions made would not commit the City Council to spend the money as a City Council vote would be needed to appropriate funds.

Mayor McMorrin received clarification that staff was looking into her request regarding signing on to an Equal Pay Pledge for the California Commission of Women and Girls, and she received City Council consensus regarding the Taste of the Nation event in May in Media Park and to consider the Juneteenth event, the Fireworks show, and the Martin Luther King Jr. Committee on April 8

Discussion ensued between staff and Council Members regarding consideration of Taste of the Nation by the Special Events Manager and subcommittee, and funding considerations for special events.

Mayor McMorrin discussed the life and legacy of former state Assemblyman and state Senator Alan G. Sieroty and James Shearin, husband of Arames Shearin.

MOVED BY VICE MAYOR O'BRIEN, SECONDED BY COUNCIL MEMBER PUZA AND UNANIMOUSLY CARRIED, THAT THE MEETING BE ADJOURNED IN MEMORY OF ALAN G. SIEROTY AND JAMES SHEARIN.
