Alicia Ide provided an update on the Artists Laurate Program and she encouraged Commissioners to contact the artists they know to apply.

Discussion ensued between staff and Commissioners regarding appreciation to Ms. Ide for her efforts; including Cultural Affairs Commission language and branding; and encouraging Council Members to participate in social media outreach.

Natasia Gascon provided background on herself, and questioned what the City was doing to support diversity and inclusion in the arts in Culver City.

Beau Basse, LeBasse Projects, provided a presentation on the project; discussed One Culver; the intent of the project; the artist selection process; he presented examples of past work for the selected artist, Jason Woodside; discussed proposed tenants; creating a visual focal point; materials; placement; fabrication; the budget; and maintenance.

Jason Woodside, Artist, discussed light, movement, depth, vibrancy, contrast, positive energy and a local tie-in.

Christine Byers, Cultural Affairs Coordinator, discussed the intent to have the art completed before the end of the year, and she noted that the mural on Washington and Higuera had faded as it did not have the protective sealant over the paint.

Discussion ensued between project representatives, staff and Commissioners regarding longevity and maintenance; materials used; the fabrication process; creating interest; documentation of the process; the timeline; dimensions; the international profile of the artist; drawing the community in; the color palette; the Tongva; community engagement; acknowledgement that the project meets requirements of the Art in Public Places Program Ordinance; and Subcommittee support of the concept.
