Public Hearings

Item PH-1

Consideration of a new Density and Other Bonus Incentives Ordinance and Finding of Consistency with the Certified EIR for the Final Culver City General Plan 2045 and Zoning Code Update Projects (Citywide)

Jose Mendivil, Associate Planner, provided a summary of the material of record.

John Moreland, Rincon Consultants, discussed components of the density bonus ordinance; the tiered bonus; proximity to transit; community benefit; annual changes to density bonus law; the flexible density bonus program created that will not require annual updates; compliance with state requirements; categories in the tiered density bonus; affordability requirements in state density bonus law; transit priority areas; transportation study criteria and guidelines; the community benefit bonus; he provided a calculation for a hypothetical project; discussed concessions; height restrictions; and he indicated that the density bonus ordinance was consistent with state law.

Emily Stadnicki, Current Planning Manager, discussed the density bonus ordinance process; distribution of affordable units; monitoring to ensure compliance; application requirements; the density bonus user guide that includes example projects and frequently asked questions; and she recommended Commission approval.

Discussion ensued between staff and Commissioners regarding the ability for designations to change if additional bus lines were added or frequency increased in an area; Metro stops; buses vs. trains; Transit Priority Areas; the height limit; and state law.

Jeanne Black provided background on herself; thanked staff and the consultants for their work; expressed support for incentivizing the creation of more affordable housing in Culver City; supported tiered density bonuses; and she was pleased to see the incentive for larger apartments and the user guide with examples of how the bonuses are calculated.

Michael Polk discussed sound issues; he felt that the Planning Commission was doing a wonderful job; and he noted that he was present to observe.

Chair Reilman acknowledged sound issues and expressed appreciation to Mr. Polk for his patience.

affordability requirements come to an end; permanent affordability; state law; usable life of a building; the ability of eligible projects to request additional feet; bringing quality development to the City; appreciation for the public comment; and adding consideration of perpetual affordability to the motion along with any specifics for the recommendation.

- 2. APPROVE A PROPOSED NEW DOBI ORDINANCE AS STATED IN RESOLUTION NO. 2025-P002 (ATTACHMENT 1); AND,
- 3. CONSIDER EXTENDING A PERPETUAL AFFORDABILITY REQUIREMENT FOR ANYTHING ABOVE STATE DENSITY BONUS.

Consideration of Citywide Residential and Mixed Use Objective Design Standards and Associated City-Initiated Zoning Code Amendment (P2024-0310-ZCA) and Exemption from CEQA

John Moreland, Rincon Consultants, provided a presentation on Objective Design Standards.

Emily Stadnicki, Current Planning Manager, discussed applicability and the review process; the ability to request deviations; concessions or waivers as part of the density

bonus project; and the ability to update the document in the future as needed through Planning Commission resolution.

Discussion ensued between staff and Commissioners regarding materials; fire safety; updated CalFire guidance; and requirements for non-combustible construction.

discretionary process; concern with being limiting with restrictions on body and accent colors on commercial buildings; clarification that the guidelines are for new construction; clarification on when standards apply; the process; concessions; and appreciation for staff efforts.

MOVED BY COMMISSIONER CARTER AND SECONDED BY COMMISSIONER JONES THAT THE PLANNING COMMISSION RECOMMEND THE CITY COUNCIL: ADOPT RESOLUTION NO. 2025-P003, RECOMMENDING TO THE CITY COUNCIL ADOPTION OF AN EXEMPTION UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) PURSUANT TO SECTION 15061(B)(3) AND 15168(C)(2), AND APPROVAL OF THE CITYWIDE RESIDENTIAL AND MIXED USE OBJECTIVE DESIGN STANDARDS AND ASSOCIATED ZONING CODE AMENDMENT TO INCORPORATE THE STANDARDS BY REFERENCE AND ENSURE CONSISTENCY WITH THE ZONING CODE.
