Daniel Hernandez, Parks, Recreation and Community Services Director, provided a summary of the material of record.

Discussion ensued between staff and Commissioners regarding the tireless dedication of Rick Hudson; ensuring that the correct field is named after him; a correction to the map page in the agenda packet; a request that the item be pulled pending receipt of City Council criteria for naming; and the Anita Shapiro request.

Barbara Silverstein discussed the tireless work of Anita Shapiro noting the request to honor her with a naming had been denied.

Discussion ensued between Commissioners regarding having the Little League or the School District honor Rick Hudson; better defining contribution; establishing criteria; the limited amount of naming opportunities; and a suggestion to withdraw the item pending clear guidance from the City Council.

Commissioner Marin suggested addressing the item another time with research regarding criteria for Syd Kronenthal and other locations that have previously been named to honor someone.

Consideration of Supporting Parks, Recreation and Community Services Department Staff's Proposed Recommendation to the City Council to Approve a Professional Services Agreement with Major League Softball to Operate the Culver City Adult Softball League

Dan Hernandez, Parks, Recreation and Community Services Director, provided a summary of the material of record.

Patricia Mooney, Senior Management Analyst, read comments submitted by:

Chair Zeidman invited public comment.

The following members of the audience addressed the Commission:

Cynthia Sampson, MLS program participant, discussed her experience managing the Blue Socks; the shift to MLS running the program; the large size of the program; things that could be improved; she expressed support for the director running the program; and she felt that MLS did a pretty good job.

Arturo Garcia, Jr., Manager of a coed team, felt that MLS did a good job overall; e discussed responsiveness; field conditions; and he expressed support for their renewal.

Bill Ward discussed his experience playing softball in the City; he expressed concern with a decline after the introductory period; the lack of enthusiasm; assertions on the MLS website; umpire issues; scheduling issues; the shortened season; communication issues; shuffling of teams; rule changes; field prep; and he felt that if MLS is approved they need to do a better job.

Dan Hernandez, Parks, Recreation and Community Services Director, reported distributing information to Commissioners, and he discussed a planned meeting before the winter season with umpires and Dan Jassim to discuss concerns and areas of improvement.

Dave Johnson, Major League Softball, introduced other MLS employees; discussed fact sheets distributed to Commissioners; participation numbers; forfeits; cards signed by players before each game; and the petition of support.

Discussion ensued between staff, Mr. Johnson and Commissioners regarding the liability waivers; the Dug Out Dirt newsletter; statistics; the program manager dedicated to Culver City; communication; willingness to correct mistakes if they are known; statistics on the website; the way the City program was run in the past; the shortened season; facilitating efficiency and balance; the RFP; rules of comparable cities; communication issues; the planned Town Hall meeting; impacts of capacity numbers; maximizing participation and revenues; the need to turn teams away; complaints received by the department; taking complaints seriously and taking the opportunity to improve communication; and the validity of the complaints.

Additional discussion ensued between staff and Commissioners regarding the quality of umpires; comparisons with other contracts; the need for additional information; concern with supporting MLS without information from other companies; clarification that the item would not generally come before the Commission; public input; instruction from Council Member Clarke to ensure that concerns voiced by the public were addressed;

agreement from staff to provide additional information on the other Leagues; recurring instances of incomplete information; concern with being asked to rubber stamp items; and making an informed decision.

Chair Zeidman proposed a motion to neither recommend nor not recommend the staff recommendation. Commissioner Kent Marin seconded the motion and the discussion continued.

Additional discussion ensued between Commissioners regarding wording of the motion and adding clarification that the Commission needed additional information.

MOVED BY CHAIR ZEIDMAN AND SECONDED BY COMMISSIONER STUART THAT THE PARKS, RECREATION AND COMMUNITY SERVICES COMMISSION NEITHER RECOMMEND NOR NOT RECOMMEND THE STAFF RECOMMENDATION TO THE CITY COUNCIL TO APPROVE A PROFESSIONAL SERVICES AGREEMENT WITH MAJOR LEAGUE SOFTBALL (MLS) TO OPERATE THE CULVER CITY ADULT SOFTBALL LEAGUE DUE TO THE FACT THAT COMMISSION FELT THAT THEY DID NOT HAVE ALL OF THE INFORMATION NECESSARY TO MAKE AN INFORMED DECISION BEFORE THEM.

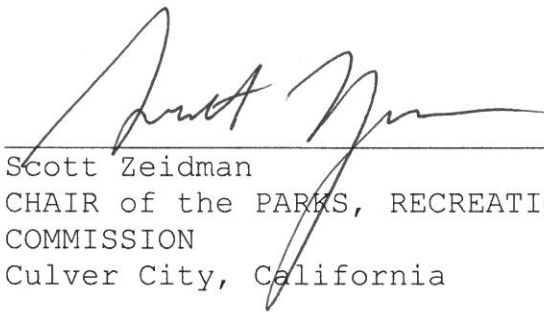
