# Update From Staff: Culver City Project Homekey Permanent Supportive Housing and Interim Housing Program

Tevis Barnes, Director of Housing and Homelessness, discussed the name change from Safe Sleep to Wellness Village; indicated that Wellness Village was at full capacity; discussed the one tent saved for emergencies; the phased move in to Project Homekey; the Mobile Crisis Team; the planned Wellness Fair on February 27; the focus on mental health; and interest from the Martin Luther King Jr. Committee in doing a service day for Project Homekey.

Discussion ensued between staff and Committee Members regarding branding for Project Homekey; visibility; the Mobile Crisis Team; development of a logo; work with the consultants; involvement of residents in the naming process;

privacy screening; occupancy; and fear experienced by those transitioning.

#### Update From Staff on 2024 Homeless Count

Christina Stoffers, Housing Programs Manager, reported receipt of permission from LAHSA (Los Angeles Housing Services Authority) to conduct an internal homeless count; discussed challenging topography in Ballona Creek; participation by staff, the ACOHH Homeless Subcommittee, and the St. Josephs Center Outreach Team; potential Council Member involvement; use of a phone app and tangible maps; and the availability of multiple virtual training sessions for participants in mid-January.

Discussion ensued between staff and Committee Members regarding use of ArcGIS; addressing issues with the app; plans to count the Creek early in the morning; date and time of the Count; ensuring that teams are diverse and work together; experienced members of the team who know where to look; risks with allowing private citizens to go certain places; the prohibition on engaging with those being counted unless they approach the enumerators; timing of information release; increased transparency; raw data vs. manipulated data; including homeless individuals who are being sheltered in the Count; the next scheduled Subcommittee meeting; final numbers for 2023; defining the sheltered designation; adjustment factors applied to cars, RVs, and tents; and the formula used by LAHSA.
