The purpose of this fee is to provide a method for the financing of public works capital improvements made necessary by permitting new development for nonresidential use. Fees from each new development shall be appropriated and disbursed only for street improvements, traffic controls and traffic management projects which are made necessary by the development and are: (a) located within the area from which the fees were collected; or (b) located within the impact zone of the new development as determined pursuant to 15.06.040; or (c) found pursuant to 15.06.045 to benefit the new development and mitigate its traffic impact.

(B) Demonstrate a reasonable relationship between the fee and the purpose for which it is charged

The City and other governmental agencies have conducted numerous studies which indicate the nature and cost of the burden and impact placed on City facilities by new development. These studies and other information show a certainty that new commercial and industrial developments generate additional requirements for traffic control and management projects and street improvements requiring capital investment by the City which may be translated into cost burden per square foot of new development, and this burden and impact is found to be not less than \$1.00 per square foot of any new development. A fee of \$1.00 per square foot for new commercial and industrial developments in excess of 5,000 square feet bears a reasonable relationship to the capital needs generated by the traffic caused by new developments and these developments benefit directly for identifiable traffic control and management projects and street improvement. The new development impact fee shall not be construed as a substitution for any City-required dedication and or public improvement adjoining a new development or subdivision, but shall be construed as a fee towards mitigating the impact of providing traffic controls, traffic management projects, and street improvements made necessary by permitting the development.

(C) Identify all sources and amounts of funding anticipated to complete financing in incomplete improvements identified in paragraph (2) of subdivision (a); and (D) Identify the approximate date on which the funding referred to in item C is expected to be deposited in the appropriate account or fund.
