with Disabilities Act (ADA).				
B. To provide funding for projects serving the elderly, the disabled				
and youth, which includes the City position of Disability Services Specialist.

8	designated and directed as the authorized representative of the City of Culver City to act in				
9	connection with the application, to execute documents relating to the application, and to				
10	provide such additional information as may be required.
