

RESOLUTION NO. 2016-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA, SETTING THE REGULAR MEETING DATES OF THE CITY COUNCIL FOR CALENDAR YEAR 2017.

WHEREAS, a Special Municipal Consolidated Election was held on Tuesday, November 8, 2016, which included Measure CD: "Shall Section 608 of the Charter of the City of Culver City be amended to authorize the City Council to determine the dates of Regular Meetings of the City Council?", which Measure passed by a majority of the voters; and

WHEREAS, the amendment to Section 608 of the City Charter shall take effect upon acceptance and filing by the California Secretary of State, pursuant to California Government Code Section 34460; and

WHEREAS, amended Charter Section 608 authorizes the City Council to determine the regular meetings at such times as it shall fix by ordinance or resolution.

WHEREAS, Culver City Municipal Code (CCMC), Section 3.01.100, states that all official, regular and adjourned meetings of the City Council shall be held in the City Hall on the second and fourth Mondays of each month at 7:00 p.m.

NOW, THEREFORE, the City Council of the City of Culver City, California, DOES HEREBY RESOLVE as follows:

Consistent with the amended Charter Section 608 and CCMC Section
3.01.100, the dates listed in Exhibit A, attached hereto and made a part hereof, are hereby set as the City Council's regular meeting dates for calendar year 2017.

1	2. The dates of the regular meetings listed in Exhibit A may only be
2	changed by the City Council's adoption of a resolution at a regular City Council meeting.
3	This Resolution shall take effect concurrently with the acceptance and
4	filing of the amendment to Charter Section 608 by the California Secretary of State.
