On 5-2-19 at approximately 0944 hours, I spoke with Animal Control Officer William Estrada of Monterey Park Animal Control through the Monterey Park Police Department (626-307-1217). ACO Estrada indicated that there is field service for animal calls daily. ACO Estrada works from 0900 hours to 1800 hours Monday through Thursday and every other Friday. There is also a part time ACO that works every other Friday and the weekends. ACO Estrada advised that after hours, Monterey Park Police Officers will respond to calls such as barking nuisance and loose dogs. However on the few occasions that there is an urgent emergency animal service call that the Monterey Park Police Officers cannot handle, Los Angeles County Animal Care and Control is contacted.

Monterey Park Animal Control has one full-time ACO and one part-time ACO.
