2 **AN ORDINANCE OF THE CITY OF CULVER CITY, CALIFORNIA,**
3 **AMENDING CULVER CITY MUNICIPAL CODE CHAPTER 11.17**
4 **“COMMERCIAL CANNABIS BUSINESSES” TO ADD A NEW**
5 **SUBCHAPTER 11.17.400 “ADOPTION BY REFERENCE OF**
6 **PART 7 OF CHAPTER 8.04, ‘COMMERCIAL CANNABIS**
7 **ACTIVITIES,’ AND CHAPTER 11.37, ‘CANNABIS FACILITIES,’**
8 **OF THE LOS ANGELES COUNTY CODE.”**

9 **NOW, THEREFORE,** the City Council of the City of Culver City, California,
10 **DOES HEREBY ORDAIN** as follows:

11 **SECTION 1.** That certain document, a copy of which is on file in the
12 office of the City Clerk, being marked and designated as “Los Angeles County Code
13 Part 7 of Chapter 8.04 ‘Commercial Cannabis Activities’ and Chapter 11.37, ‘Cannabis
14 Facilities’” (collectively “Cannabis Public Health Ordinances”) adopted by the County of
15 Los Angeles December 19, 2017, and each and all of the regulations, provisions,
16 penalties, conditions and terms of said Cannabis Public Health Ordinances on file in the
17 office of the City Clerk of Culver City, is hereby referred to, adopted, and made a part
18 hereof, as though fully set out in this ordinance, with the additions, insertions,
19 amendments, deletions and changes, if any, prescribed in Section 2 of this Ordinance.

20 **SECTION 2.** A new Subchapter 11.17.400, “Adoption by Reference of
21 Part 7 of Chapter 8.04, ‘Commercial Cannabis Activities,’ and Chapter 11.37, ‘Cannabis
22 Facilities,’ of the Los Angeles County Code,” is hereby added to Chapter 11.17 of Title
23 11 of the Culver City Municipal Code, to read as follows:

24 ***Adoption by Reference of Part 7 of Chapter 8.04, ‘Commercial Cannabis***
25 ***Activities,’ and Chapter 11.37, ‘Cannabis Facilities,’***
26 ***of the Los Angeles County Code***

27 **§11.17.400 Adoption by Reference of Los Angeles County Cannabis**
28 **Public Health Ordinance.**

1 A. The City of Culver City hereby adopts by reference Part 7 of
2 Chapter 8.04 "Commercial Cannabis Activities" and Chapter 11.37 "Cannabis Facilities"
3 of the Los Angeles County Code, dated December 9, 2017. The provisions of the Los
4 Angeles County Code described herein shall be applicable in the City and referred to as
5 the City's Cannabis Public Health Ordinance.

6 B. A copy of Part 7 of Chapter 8.04 "Commercial Cannabis Activities"
7 and Chapter 11.37 "Cannabis Facilities" of the Los Angeles County Code shall be
8 available for public inspection in the City Clerk's office.

10 **SECTION 3:** Pursuant to Section 619 of the City Charter, this Ordinance
11 shall take effect thirty (30) days after its adoption. Pursuant to Section 616 and 621 of
12 the City Charter, prior to the expiration of fifteen (15) days after the adoption, the City
13 Clerk shall cause this Ordinance, or a summary thereof, to be published in the Culver
14 City News and shall post this Ordinance or a summary thereof in at least three places
15 within the City.


