Council Member Eriksson asked that the City Manager consider displaying blue and white on Veterans Tower in support of Israelis in defending themselves.

Vice Mayor McMorrin expressed gratitude for recognitions; announced that October is National Women Small Business Month; discussed the Chamber of Commerce; upcoming events; continued support of small businesses; International Day of the Girl on October 11; Domestic Violence Awareness Month; increasing community safety; different types of domestic and familial violence; and she announced a County Budget Workshop put on by Supervisor Holly Mitchell on October 16.

Mayor Vera read an excerpt from a statement from Sydney Kamlager Dove unequivocally condemning the Hamas terrorist attack on innocent civilians, and he received unanimous City Council consensus to light up Veterans or City Hall in blue and white, and to craft a resolution in support of Israel.

Item I-1

CC - Update on Homelessness Emergency Including Project Homekey, Safe Camping, and Other Housing Programs (This update is made pursuant to the requirements of Government Code Section 8630(c) requiring a periodic review of the local emergency)

Tevis Barnes, Housing and Human Services Director, presented a video of the Ribbon Cutting and Grand Opening of Project Homekey on September 29, 2023; discussed work with Saint Joseph Center (SJC) and Exodus Recovery; the By Name List; residents of the site; the phased opening; the warm hand off from SJC to Exodus; the move-in kit; the interim housing side; the permanent housing side; access to supplies; gift cards for additional home items; accountability to the neighbors on Atlantic Avenue; she thanked Council Members for attending the ceremony and staff for their tireless efforts; and she noted that the video was also available on the City website.

Dr. Daniel Richardson, Human Services and Crisis Intervention Manager, provided an update on Emergency Homeless Service in the City; discussed Camp Facility Action and Engagement Protocol; identifying and responding to locations in the City; procedures to facilitate the removal of tents and makeshift structures, and provision of supportive services, housing, and shelter; the definition of camping facilities; departments involved in the process; and the four step City response to camp facilities.

Discussion ensued between staff and Council Members regarding clarification that after four attempts to provide services, a notice would be posted about the intent to remove items, with any belongings not claimed 90 davs; disposal of after collaboration with the Sheriff's Department; communication; the ability to extend the storage timeframe; the ability to allow additional attempts to provide services before removal of items; appreciation for the presentation and staff efforts; the Mobile Crisis Team; the training period; field work; implementation; the phased move-in; concern with discretionary policy; the 72 hour notice; instances where immediate action is needed; the record of response time; sweeps; notification; available resources; consistent service and outreach on Tuesdays; average number of interactions; service resistant individuals; number of touches specified on procedures vs. actual number of interactions; barriers to services; number of interactions over the years; services provided during the transitional state; options offered; the wait list; drug use; staff time involved with Camp Facility Engagement and Action Protocol; lack of a plan for auditing and accounting of time spent on the action protocol; understanding the time spent on Code Enforcement; understanding the investment being made in the new program to evaluate success of the program; ensuring transparent policy; time spent by different departments; establishing an accounting system; enforcement as part of efforts to get people indoors; and City Council consensus was achieved from Vice Mayor McMorrin and Council Members O'Brien and Puza to direct staff to evaluate the amount of staff time being spent on Camp Facility Engagement and Action Protocol.

Additional discussion ensued between staff and Council Members regarding reasons for reluctance to accept services; efforts to address barriers; trust; those who are not ready to accept services; helping people transition; and appreciation to staff for their efforts to reduce barriers.

Mayor Vera introduced the item; he presented the video: "Culver City: Building an Inclusive, Accessible Community"; and he expressed appreciation to the everyone for their efforts.

Joint Public Comment - Items NOT on the Agenda

Mayor Vera invited public comment.

The following members of the public addressed the City Council:

Stephen Jones reported that the updated interactive map at ccrentals.org was available including new rental units that had registered for the first time; he discussed concerns that the availability of information would reduce registration; putting information in the hands of tenants; shifting information asymmetry that leads to higher rents; and he indicated that additional information was available by writing to info@ccrentals.org.

Corrine Walder was called to speak but did not respond.

Kelli Estes expressed agreement with the need for accounting related to the homeless plan; discussed the MOVE Culver City Project; the Overland bike lane; changes proposed by staff; difficulty making a left turn on Galvin; she asserted that closing a lane of traffic would make matters worse; noted that Overland is a neighborhood with many driveways and off street parking; discussed pass through traffic in the City; the need to take a realistic look at planning and utilize what already exists; the little-used north/south bike lane on Sawtelle; taking a realistic look at buses; and she felt that continued restrictions would lead to unintended consequences.

Jesse Nuñez, Culver City Chamber of Commerce, thanked the City for their support of women business and community leaders, and invited everyone to the 8th Annual Women in Business Leadership Awards on October 26 at the Four Points Sheraton.

Rebecca Rona, Equity and Human Relations Advisory Committee, invited everyone to the Latino Heritage Month Celebration at

the Teen Center on October 10; indicated that fliers were available; and she discussed planned activities.

Ron Bassilian, Protect Culver City, indicated that Richard Glazer had ceded him a minute, provided background on himself; discussed the need to make the City a safe place for everyone; hosting vagrant camps; funding CCPD; unscrupulous activities; dubious legal claims; personal attacks; he and he felt that the best thing the City Council could do as a friend to Israel would be to keep Culver City a safe place.

Melissa Sanders reminded everyone that the Farragut Fall Festival would be on October 21 and she discussed planned activities.

Ronald Ostrin was called to speak but did not respond.

Khin Khin Gyi, Citizens Coalition for a Safe Community, reported attending a recent community meeting where issues of concern were discussed including: the relocation of parking spots related to a proposed bike path from Ballona Creek to Jefferson; concern with implementing a bike path without a traffic study; and she felt the issue should be agendized for reexamination.

Carlos Valverde was called to speak and Rebecca Rona indicated that she had spoken on his behalf.

Chad Kroeger discussed disarray in Congress and he asserted that Taylor Swift could reunite everyone by dating the next Speaker of the House.

JT Parr echoed comments made by the previous speaker and sang a portion of Taylor Swift's song, "Blank Space."

Andrew Lachman reminded the City Council that the Finance Advisory Committee (FAC) has two openings that need to be filled; announced the El Marino Fall Festival on October 28; discussed current events; and thanked the City for standing by Israel during a difficult time for the community.

Bubba Fish discussed efforts to lower the voting age; civic engagement and advocacy; research indicating the ability of 16 year olds to vote responsibly; and he asked the City Council to bring the ballot measure back for the next election. Karim Sahli echoed comments made by the previous speaker; discussed democracy; visionary leaders; allowing participation in the future; guaranteeing stronger and more informed participation; the right to express an opinion on democracy; the ability of 16 year olds to drive; and he wanted the Vote 16 Measure placed on the ballot again.

Keith Jones discussed approval of police military equipment; terrorism in Israel; the need to be able to protect citizens and businesses; he wanted to defend, not defund CCPD;

Jack Galanty was called to speak but did not respond.

Julia Rottenberg, Culver City High School Senior, noted that due to the narrow margin of defeat, Vote 16 warranted reconsideration; discussed voter turnout during the last election; evidence that voting in one election increases the probability of future voting; raising a generation of habitual voters; and she noted that democracy was stronger with more participation.

Nancy Barba requested that the City Council support agendizing reconsideration of the Vote 16 measure for the 2024 ballot; discussed the importance of civic engagement; the narrow margin; and demonstrated community interest on the matter.

Rick Tuttle discussed difficult times in the Middle East and expressed appreciation for indications of support for Israel.

Nava Waisman, Culver City High School student, expressed support for adding Vote 16 to the 2024 November election; discussed the slim margin of defeat; the number of people participating in the election; creating a generation of habitual, civically minded voters; increasing the probability of voting; local legislation that directly affects teenagers; and the need for a generation of political awareness and advocacy.

Adam Ferguson, Senior Management Analyst, provided a summary of the material of record.

Discussion ensued between staff and Council Members regarding the illness exemption; reasons given for absences; lack of notification; and lack of a quorum for the August meeting due to the absence of Mr. Cuffe who had indicated that he would attend.

Mayor Vera invited public comment.

The following members of the public addressed the City Council:

Crystal Alexander, Parks, Recreation and Community Services (PRCS) Commissioner, spoke on behalf of herself noting that she had not met Mr. Cuffe; discussed the robust Commission work program and the need for all Commissioners to be present; newly created subcommittees; and she asked about off-cycle appointments.

Ronald Ostrin expressed appreciation for comments made by Jeannine Wisnosky Stehlin; discussed the importance of active participation by Members; and he hoped that the City Council would take the matter seriously noting the amount of work that needs to be done.

Jane Leonard, PRCS Commissioner speaking on behalf of herself; discussed time, effort, thought, consideration, and commitment; lack of notification; professional courtesy and respect; and the important leadership role.

Council Member Eriksson moved to the deny the request from Khary Cuffe to be reappointed to the PRCS Commission and Mayor Vera seconded the motion.

Discussion ensued between staff and Council Members regarding appreciation for those who raise their hand to serve; those with children; those impacted by policy decisions; providing notice; representation; the important perspective provided; rules; number of meetings missed vs. consecutive meetings missed; residency; clarification that Mr. Cuffe had attended 50% of the meetings held since his appointment; and concern that despite being notified about the current item, he was not present.

MOVED BY COUNCIL MEMBER ERIKSSON AND SECONDED BY MAYOR VERA THAT THE CITY COUNCIL: DENY THE REQUEST FROM KHARY CUFFE FOR REINSTATEMENT TO SEAT NUMEBR 5 OF THE PARKS, RECREATION AND COMMUNITY SERVICES COMMISSION.

CC - (1) Review and Approval of the 2022-2023 Culver City Police Department Military Equipment Annual Report Pursuant to Government Code Section 7071(e)(2); (2) Review and Renewal of (i.e., Continuation of) Ordinance No 2022-005, Codified as Subchapter 3.04.400 of the Culver City Municipal Code, Governing the Use of Military Equipment by the Culver City Police Department, Pursuant to Government Code Section 7071(e)(1); and (3) Direction to the Police Chief as Deemed Appropriate

Jason Sims, Police Chief, provided a summary of the material of record noting that five drone deployments had inadvertently been left off the report.

Lieutenant Ryan Thompson presented the annual report.

Discussion ensued between staff and Council Members regarding clarification that there would not be any new purchases until 2024; amount spent on ammunition and training; the number of specialized firearms; the decrease in the number of sworn positions; issuing firearms to specific officers; ensuring ownership and maintenance; the 1033 program; reclassification of positions; clarification that there was no defunding of CCPD nor were people cut from CCPD; current number of vacancies; surplus rifles; and drone deployments.

Mayor Vera invited public comment.

The following members of the public addressed the City Council:

Stephen Jones discussed the CCPD budget; drone usage; tracking errors; violation of policy; resident oversight; concern with unwillingness to admit mistakes; compliance with transparency laws; state law; lack of complete or required information regarding training; ammunition inventory discrepancies; bare minimum reporting that does not meet requirements; limits on usage unless for a deadly shooter or hostage situation; usage against unarmed individuals; Guillermo Medina; responsibility of those who voted to approve the guns; gun related deaths in the City at the hands of CCPD; and he asked that the City Council vote no and get the guns out of the City.

Corrine Walder was called to speak but did not respond.

Deborah Weinrauch was called to speak but did not respond.

Jamie Wallace noted that the law was passed and CCPD had met the requirements, and she felt that the City Council should approve the annual report and reauthorize usage.

Melissa Sanders provided background on herself; echoed comments made by Jamie Wallace; wanted additional security; trusted CCPD and their reporting; expressed gratitude for having a dedicated police and fire department noting that those who did not appreciate that could move to Los Angeles; and she asked the City Council to approve the item.

Ronald Ostrin reported reading the report; felt that the equipment was making people safer; noted hearing the same voices expressing prejudice and bias against CCPD; acknowledged a sad incident; discussed the need to supply necessary equipment to ensure preparedness; and he hoped the City Council would not listen to biased voices.

Bubba Fish discussed approval of the previous request from CCPD; money spent to close a gun store; concern with reauthorizing an arsenal of military grade rifles in the City; the percentage of homicides committed by the police nationwide vs. in Culver City; Guillermo Medina; usage against people of color; a state report indicating CCPD had the worst discrepancies of any in the state; he echoed concerns voiced by Stephen Jones; and noted CCPD's lack of compliance with state reporting requirements.

Karim Sahli expressed opposition to the militarization of CCPD; discussed the murder of George Floyd; demonstrations; ensuring that Culver City does not become the next Ferguson, Missouri; fearmongering; the unprecedented homeless crisis; failed enforcement; and he felt that the City needed to prioritize the department most involved in alleviating the crisis.

Keith Jones thanked the City Council for their efforts; discussed the misnomer of military weapons; usage by everyday citizens; weapons that are not considered military style; usage to protect citizens; continuing the ability to defend the City; policing neighborhoods without guns; other cities that are not safe; and he wanted the City Council to approve the item to continue to provide protection for the citizens.

Nancy Barba echoed comments from previous speakers requesting that CCPD be held responsible for the report; discussed reports from other cities; the community meeting and concern that response to community questions was direction to go to the website; the need for complete and detailed reports; lack of compliance; and she encouraged the City Council to examine the reports from Santa Monica.

Jeff Cooper expressed appreciation for the comprehensive report and for addressing information about drone usage; discussed the importance of providing tools to protect everyone; hope the tools would not have to be used; and he looked forward to City Council approval of the report.

Discussion ensued between staff and Council Members regarding litigation related to the officer involved shooting; additional information available at culvercitypd.org; the critical incident video; the public meeting; quarterly reports available online; transparency; making information available to the community; concerns related to ammunition; the inventory report; reclassification of ammunition; utilization for training; providing copies of the quarterly report; and concern that if the item is not passed, tools for de-escalation would be removed.

Mayor Vera moved to approve the 2022-2023 Culver City Police Department Military Equipment Annual Report.

Further discussion ensued between staff and Council Members regarding decisions about what type of military equipment is used; utilization criteria; officer discretion; usage protocol; AB 481; specialized firearms; instances when rifles have been used; clarification on what constitutes a deadly threat; lack of transparency; deployment of different weapons; de-escalation tactics; less lethal options; acknowledgement that descriptions could be more descriptive; those who want to move from systems of punishment and criminalization to systems of care and investment in people and in the community; the budget as reflecting community values; crime happening despite the investment being made; addressing symptoms rather than root causes; the Mobile Crisis Intervention Unit; providing services; providing more transparency and accountability; trust issues between CCPD and the community; communication; meeting minimum requirements vs. going beyond in order to address trust issues;

expenses; the feeling that the more weapons there are, the more they will be used; purchase of the Martin B. Retting Gun Store; and making a commitment to reduce weapons.

Additional discussion ensued between staff and Council Members regarding the feeling that the report satisfied the requirement; staff responsiveness; lack of trust; the public meeting; ensuring a functioning police department; the location of Culver City in the middle of Los Angeles; people arrested who are not Culver City residents; and encouragement for people to join the Citizen's Police Academy.

Council Member Eriksson seconded the motion to approve the report.

Further discussion ensued between staff and Council Members regarding the difficulty of addressing root causes of crime when most of those arrested are not from Culver City; adoption of the ordinance last year; review of the report by the City Council; incorporating lessons learned into the process for next year; type and capacity of weapons; different tools available; use in specific circumstances; improving the report with feedback; providing in depth information; the Annual Usage Report; RIPA (Racial Information Profiling Act) reporting; and availability of staff to address concerns.

Discussion ensued between staff and Council Members regarding appreciation for the report and for comments from the community; the history of policing; the feeling that if people get to know the officers they will understand the system; founding of the policing system in the country from slave patrols; enforcement of Jim Crow laws and segregation; Culver City as a Sundown Town; the relationship between policing and state sanctioned violence; lived experience; acknowledging how residents experience the system; United States as having a largest prison population; costs to keep people in prison; incarcerating as a way to provide safety; the fact that police protect power and property; effects to the most marginalized; access; spending money to keep people safer with traffic calming; accountability; continued issues with ensuring a framework for decision making; the short community meeting; additional work to build trust and engage neighbors; accountability and responsiveness to all neighbors; the process for making a complaint; concern that nothing has been done with the RIPA data to shift the disproportionate outcome in use of force; CCPD as having the worst record for use of force against Black people in the state; finding a way to address disproportionate harm; accountability; comparing numbers with people interacting in the community and the residential population; providing an accurate representation; arrests generated by the public; use of force in arrest situations; providing context; discrepancies; confusion with the data; the importance of providing clarification with the RIPA data from 2021; opposition to militarization of the police; concern with using military tools on civilians; reducing access to weapons designed for the battlefield of war since Culver City is not part of a war zone; and support for a more streamlined complaint process, more transparent reports, and providing more community engagement with a more robust exchange with neighbors moving forward.

Further discussion ensued between staff and Council Members regarding the Use of Force policy; the Government Alliance on Race and Equity (GARE); triggering a documentation requirement; the Use of Force review process; tracking procedures; identification of training and policy issues; internal investigations; data collection issues on the state use form; lack of trust that is not conducive to dialogue; taking less than lethal weapons out of service; the racist past of the City; celebrating progress made; the need for compromise; and acknowledgement of work to be done.

Onyx Jones, Assistant City Manager, introduced the item.

Punit Chokshi, Senior Management Analyst, provided a summary of the material of record.

Onyx Jones, Assistant City Manager, discussed review by the ad hoc subcommittee; consensus to review the City of Los Angeles Minimum Wage Ordinance; and potential next steps.

Mayor Vera invited public comment.

The following members of the public addressed the City Council:

Stephen Jones was called to speak but did not respond.

Corrine Walder was called to speak but did not respond.

Jesse Nuñez, Chamber of Commerce, expressed support for approval of the professional service agreements with BEAR.

Jamie Wallace was called to speak but did not respond.

Melissa Sanders was called to speak but did not respond.

Ronald Ostrin discussed the necessity of a study; paying a minimum wage similar to that in Los Angeles; the importance of jobs for young people; allowing a lower wage to be paid for young people for a longer period of time; providing flexibility for businesses; and he expressed concern with the City spending money for studies that often have a predestined, political conclusion.

Karim Sahli thanked staff for the presentation; expressed agreement with comments made by the previous speaker regarding the necessity of the study; expressed disagreement with paying younger workers less money; discussed the study being done by Los Angeles; saving money and time by not paying for another study; resources that could be used to address homelessness; the need for a \$27 minimum wage to live in Los Angeles; and moving forward in a faster and more efficient manner to resolve issues.

Keith Jones was called to speak but did not respond.

Nancy Barba was called to speak but did not respond.

Discussion ensued between staff and Council Members regarding poverty; low wages that create obstacles for people; crime; the increased cost of living; wage inequality; homelessness; achieving stability; willingness to align with Los Angeles; the requirement that a study be conducted in order to move forward; the need to remain competitive with neighboring cities; restaurants losing servers because they cannot keep up with wages; and tying the minimum wage to the City of Los Angeles.

Additional discussion ensued between staff and Council Members regarding regulatory work done in Los Angeles; the need for specialists in order to establish a division in Culver City; costs to run a program; revenue related to fines and penalties with non-compliant businesses; assistance with regulation from government agencies; understanding what is involved with making changes; consideration of impacts to businesses; specific costs related to doing business in Culver City; creating a carve out for servers who earn more money per hour than other employees; differing viewpoints on studies; the need for consistency; and execution of an unbiased and fair assessment.

Further discussion ensued between staff and Council Members regarding appreciation for the public comment and efforts of staff; car-dependent infrastructure; increased cost of gas; the ability to help working class families; a groundbreaking study done by UC Berkeley on small business and minimum wages; lack of evidence that raising the minimum wage harms businesses; California as the epicenter of wage theft; average housing costs in Culver City and in Los Angeles; challenges for working families and students; support for tying the minimum wage to that of Los Angeles; costs for the study; examining the success of West Hollywood; non-profits and other institutions that might have a hard time; and the ability to take immediate action to help working families. Vice Mayor McMorrin moved to tie the minimum wage in Culver City to the minimum wage paid in Los Angeles.

Additional discussion ensued between staff and Council Members regarding the current agenda item; the need for an item to return specific to raising the minimum wage to that of Los Angeles; procedures for placing an item on the Consent Calendar; political expediency; agreement that the minimum wage should be increased; insuring everyone is paid a livable wage; ensuring equity for the economy; the experience of businesses in West Hollywood; changing business models; labor layoffs; the importance of listening to everyone; previous discussion and consensus about having a discussion of linking the ordinance to Los Angeles; and the need for an ordinance in order to move forward.

MOVED BY VICE MAYOR MCMORRIN AND SECONDED BY COUNCIL MEMBER PUZA THAT THE CITY COUNCIL DIRECT STAFF TO BRING BACK AN ORDINANCE TYING THE MINIMUM WAGE TO THAT OF LOS ANGELES WITHOUT A STUDY.
