This permit is granted subject to the following conditions and/or restrictions:

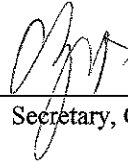
1. That the permittee pays promptly all necessary permit and license fees and fully comply with all applicable laws.
2. This permit may be canceled at any time in the event that the activity for which this permit has been granted becomes detrimental or objectionable to the public health, morals, safety or general welfare; or it conflicts with any city, State or Federal law.
3. The event is contingent upon the Culver City Exchange Club/Culver City Car Show (the "Event Operator") executing a license agreement with the City, which will include insurance provisions, indemnification provisions, signage, and conformance with noise ordinance and reimbursement to the City for loss of borrowed equipment.
4. Applicant shall implement a program with concrete steps and procedures, and with adequate staffing, to prevent participating display vehicles from forming a queue on any public right-of-ways. Such Queue Prevention Program is articulated in Engineering Attachment 1 (as revised for 2016), and it shall be implemented by the Applicant. Minor field-modifications and tweaking may be necessary and Engineering staff will be available on the day of the Car Show, to consider changes proposed by the Applicant.
5. One week prior to the event, the Event Operator will notify all downtown businesses of the upcoming event.
6. All advertisement and publicity shall indicate that event parking is available only at designated parking lots and parking structures. Additionally, all such advertisement and publicity shall notify the public that there is "NO PARKING IN RESIDENTIAL AREAS".
7. A minimum of 4 foot clearance shall be maintained on all sidewalks within the perimeter of the Car Show. Additionally handicap ramps, and marked and unmarked crosswalks shall be maintained unobstructed to accommodate pedestrian access.
8. Applicant shall hire a Traffic Control contractor who will be responsible for providing all the traffic control equipment, staffing, and industry knowledge and licensing, to implement the Traffic Control Plan as approved by Engineering. Setup and tear-down will be effected by Applicant's Traffic Control Contractor. Engineering reserves the right to alter, modify, change, and add Traffic Control in reaction to field dynamics on the date of the event. Applicant's contractor shall immediately comply as required by Engineering.
9. Applicant's Traffic Control contractor shall provide to staff, the name and cell phone number for the contractor's event supervisor present in the field, in order to facilitate, coordinate and respond to staff's requests.
10. Applicant to provide Engineering with a graphic illustrating and quantifying the parking lots/structures utilized for staff parking and event parking.
11. Applicant to provide Engineering with a graphic illustrating the locations and names of booths contained within the Car Show area and a schedule/program for the event.
12. Other pertinent permits may be needed by participants and are not part of this event permit; such as Transportation Permits, Lane Closure Permits (prior to closure of the streets), etc. Additionally, all insurance and business license requirements shall be complied with by all participants.
13. Applicant shall provide a dedicated traffic lane on Culver Blvd. for use by emergency vehicles.
14. Applicant shall have chain link fencing as shown on the Culver City Car Show Map, that is a minimum of 4 feet in height. The lane shall traverse the entire event site on the south side of Culver Boulevard-Washington Boulevard.

15. The chain link fencing shall be used to establish a dedicated 20' lane for emergency vehicles. The only openings in the chain link fencing shall be at existing public intersections where there are marked crosswalks, and at the Culver City Fire Station #1.
16. For 2016, such openings may be provided at Lafayette, from the Fire Station #1 through Irving Place (adjacent to Santa Maria BBQ), at Cardiff, and at Main Street, adjacent to the Culver Hotel.
17. Culver City Police Department will be involved with the traffic control.
18. Temporary "No Parking" signs shall be posted from Washington Blvd. /Hughes Ave. (northwest corner) heading westbound to the entrance of the parking structure just west of El Pollo Loco.
19. Event Operator shall notify both public and private emergency paramedic services that report to Brotman Hospital, of the routing of vehicles.
20. Event Operator shall provide a minimum clearance of 20 feet in width to all areas of the closed off streets in order for a fire engine and or rescue van to gain entrance in the case of an emergency.
21. Event Operator will work with the City to provide a list of all the events that are scheduled in Downtown on the day of the event. Applicant will work with the Traffic Engineering Manager to develop traffic plan to accommodate any other events occurring in Downtown the same date as the Car Show.
22. Event Operator will provide the Traffic Engineering Manager with a map indicating where the trailers, service vehicles, and display vehicles will be parked during the Car Show.
23. Event Operator shall submit a traffic control plan to the Traffic Engineering Manager for approval. The Event Operator shall place traffic control elements per the approved traffic control plan and "WATCH" Manual and/or California Manual on Uniform Traffic Control Devices.
24. All directional signage and related locations shall be approved by the City's Traffic Engineering Manager and the City Attorney to ensure compliance with City sign regulations and compliance with the License Agreement.
25. Changeable message signs shall be placed in various locations (at the Event Operator's Expense) to assist the drivers who are being diverted because of the event. The specific location shall be determined by the City's Traffic Engineering Manager.
26. The approved street plan shall clearly identify where volunteer stations will be located.
27. On the day of the event, field-work (such as installing fences or booths) shall not commence until the streets have been completely closed to traffic by Applicant's contractor.
28. The Event Operator shall reimburse the City for street sweeping.
29. The Event Operator shall be responsible for ensuring vendors clean their booths prior to concluding the event. In the event City staff is required to clean up vendor's booths, the Event Operator shall reimburse the City for any cost incurred.
30. All contracts with vendors shall include Fire Department fire safety guidelines for outdoor carnivals & fairs.
31. All vendors shall receive and sign the Event Operator's vendor policy. Failure to adhere to the policy may result in an administrative assessment by the City against the Event Operator and/or the vendor.
32. The Applicant shall provide ADDITIONAL TRAFFIC CONTROL at the Hughes/Washington intersection-Bus Stop located on the north side, west of Hughes.
33. The Applicant shall provide ADDITIONAL TRAFFIC CONTROL at the intersection of Ince/Washington-providing a soft closure at Canfield/Venice; also, directing northbound traffic on Ince which must turn right onto eastbound Culver, as directed by Engineering prior to the event or in the field on the day of the event.
34. PUBLIC NOTIFICATION: The Event Operator will release at his cost, a Public Announcement notice in the local newspaper, that includes a map, two weeks before the event, to run once each week, providing information, a map, and the notice that there is no car show parking in the residential community. A copy of the proof of publication to be provided to Traffic Engineering Manager.
35. A Traffic Control Sub-committee consisting of the Event Operator, the Traffic Control Contractor, Traffic Engineering Manager (or his designee), and the Public Works Inspector shall be formed. This Sub-committee will meet at least a week before the event to walk the Car Show perimeter and confirm the understanding and expectations of all relevant parties regarding the needed traffic control.
36. The Event Operator to install all signs giving prior notice of the event on the appropriate arterials, as per the Signage Plan determined by the Traffic Engineering Manager, and according to a schedule agreed to in preparatory meetings.
37. ELECTRICITY NEEDS: The Event Operator, to ensure the availability of electricity, shall provide a comprehensive electrical plan, indicating the Car Show's electrical needs, which can be developed with staff's help.
38. Loading and unloading of vehicles from flatbed trucks and other vehicles or trailers, will be coordinated with Public Works staff.
39. The Event Operator shall provide notice of the event to the Metropolitan Transit Authority and the Los Angeles Fire Department.
40. In addition to Culver City permits, the Event Operator shall obtain all necessary permits (Street Closure, etc.) from the City of Los Angeles and any other governmental agencies, as appropriate.
41. Applicant shall provide the City of Culver City spaces for three (3) clean fueled vehicles to be placed on display at the event.
42. Only persons authorized by the City may operate City GEM cars.
43. Event Operator must obtain an amplified sound permit and work with the City to mitigate noise impacts on adjacent neighborhoods.
44. Conditions of Use of Town Plaza for display of two vehicles:

- Vehicles will need to be loaded in via Culver Blvd. (A Street, behind Pacific Theatres, in not an option due to an issue with the bollards.) Any damage to the curbs, surface, landscaping, and/or utilities, shall be repaired by qualified contractors within three business days after the Car Show, under a permit from Engineering, and to the satisfaction of the City Engineer.
 - If the subject two vehicles are towed to the location, the towing vehicle shall not drive onto the Town Plaza surface, but shall offload the vehicle onto the Town Plaza surface from the Culver Boulevard roadway, and the display vehicles will drive to the designated location.
 - Vehicles will need to be parked at least 10' from the Lion's Foundation where indicated by Engineering on the attached plan.
 - Vehicles will need to be parked on top of a material to absorb any oil. The absorbent material shall be completely picked-up and properly disposed, as per applicable laws.
 - Upon conclusion of the Car Show, the two display vehicles shall drive to the Culver Boulevard curb edge of Town Plaza and the towing vehicle, if any, shall load the vehicle from the roadway.
 - Fire access lane on the northeast side of Pacific Theatres shall remain clear of any obstructions from A street to the Culver Hotel
 - Vehicles shall not block egress from the businesses located on Town Plaza
