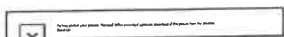

eComment: Hi, I am a homeowner in Lindberg Park with property backing up to the alley on Overland Ave. Our family feels strongly about addressing California's housing crisis and climate change. This Amendment allows us to tackle both, which is amazing. As proposed, it would be possible for us to convert our non-conforming (1-car) garage to an ADU, plus build a driveway in the front of the house with chargers for two EVs. Without this amendment, we can't get a permit for a driveway and if we build the ADU, we are stuck with street parking, which means we can't have EVs unless the City installs chargers on the sidewalks. Thank goodness for the wisdom of the Planning Commission! Please approve this amendment and let our family contribute to making Culver City part of the solution to these major problems!!
