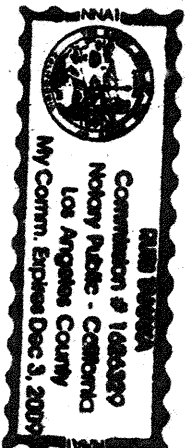

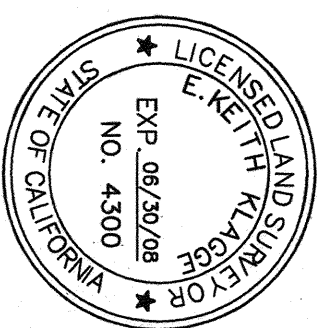

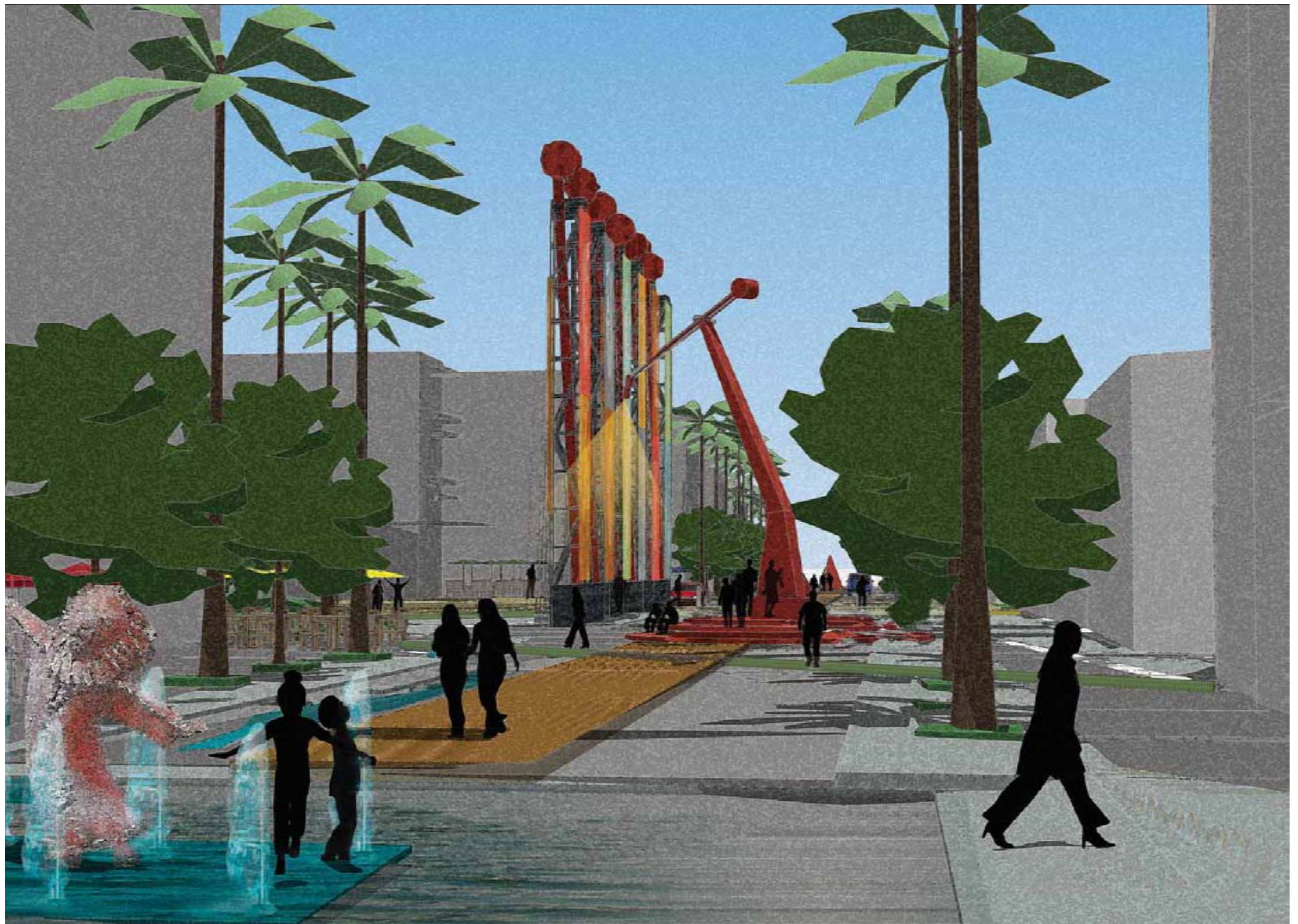


2. Examples of Pylons and Their Uses:





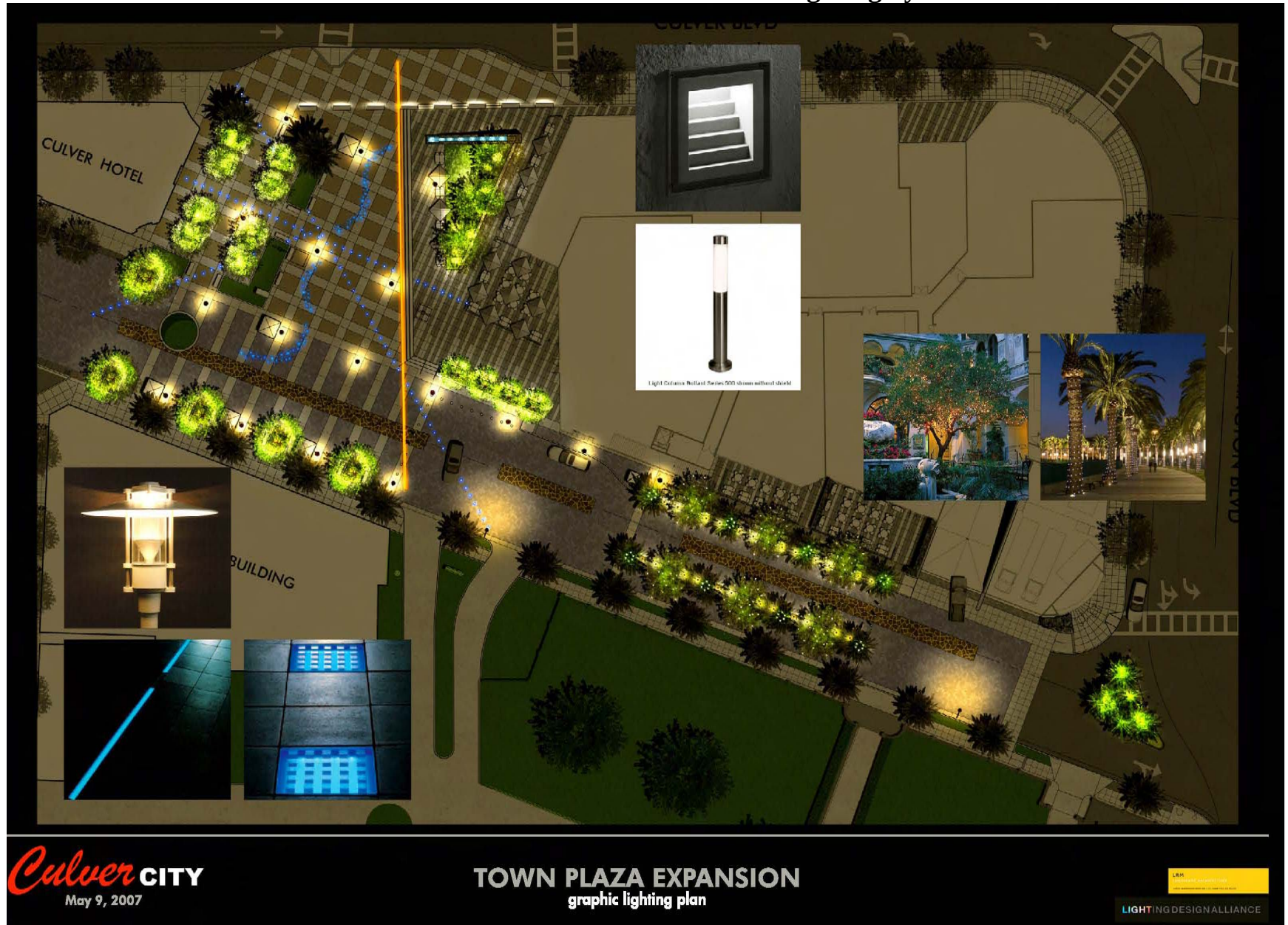
