Why should the nominee receive the recognition?

Founded in 1976, the Disability Community Resource Center (DCRC) (formerly Westside Center for Independent Living) has served people with disabilities for almost 50 years including Culver City residents. Moreover, DCRC has been a leader is disaster preparedness and emergency preparedness training and resources for the City of Culver City, working with Christine Parra (the emergency manager) to review the City's 2024 Emergency Operation Plan to ensure it addressed the needs of the whole community – including people with disabilities; some of which were utilized to make updates to the plan.

What is the nominee doing or have they done to benefit individuals with disabilities in the past year(s)?

Disability Community Resource Center (DCRC), founded in 1976, is a Center for Independent Living or CIL. CILs are community-based, cross-disability, non-profit organizations that are designed and operated by people with disabilities. CILs are unique in that they operate according to a strict philosophy of consumer control, wherein people with all types of disabilities directly govern and staff the organization. CILs provide: Peer Support, Information and Referral, Individual and Systems Advocacy, Independent Living Skills Training, and Transition Support.

DCRC is dedicated to supporting people with disabilities and seniors to achieve and maintain self-directed and community based independent lives. DCRC's members are a diverse group of people of all ages and from all ethnic, cultural and socioeconomic backgrounds. To serve this population, we provide services in English and Spanish as well as having language line services available to provide communications in all the principal languages spoken in Los Angeles County. We are also equipped to provide communications and services to members using Assistive Technology devices, thereby facilitating our work with members who may be blind or deaf. We work together with persons living with any type of disability, including but not limited to intellectual, developmental, hearing, learning, mobility impaired, physical, mental health, substance abuse, traumatic brain injury and visual disabilities. We serve the communities of: Baldwin Hills, Beverly Hills, Brentwood, Carson, Century City, Cheviot Hills, Culver City, El Segundo, Fox Hills, Gardena, Harbor City, Hawthorne, Hermosa Beach, Inglewood, Ladera Heights, Lawndale, Lomita, Malibu, Manhattan Beach, Marina Del Rey, Mar

Vista, Pacific Palisades, Palms, Palos Verdes, Playa del Rey, Playa Vista, Rancho Park, Redondo Beach, Santa Monica, San Pedro, Torrance, Venice, Westchester, West Hollywood, West Los Angeles and Westwood.

Though only about 2% of our clients reside in Culver City, DCRC has been a leader is disaster preparedness and emergency preparedness training and resources for the City of Culver City working with Christine Parra (the emergency manager) to review the City's 2024 Emergency Operation Plan to ensure it addressed the needs of the whole community – including people with disabilities; some of which were utilized to make updates to the plan. Moreover, DCRC staff provided training to staff of the Culver City Youth Camp on the working with people with disabilities as well as an overarching review of the ADA and other aspects of disabilities.

Most recently, in response to the Palisades and Eaton Canyon Fires, DCRC was the recipient of a grant from the Albertson's Foundation to assist wildfire victims with disabilities in restoring lost durable medical equipment including power wheelchairs.

Echo Center/Echo Horizon School

Why should the nominee receive the recognition?

The nominee should receive recognition for its exceptional commitment to inclusive education through the Echo Center program. At Echo Horizon School, approximately 15 percent of the student body is deaf or hard of hearing (DHH) and uses hearing technology. Rather than being served in a separate setting, these students learn side by side with their hearing peers, who make up the remaining 85 percent of the school community.

As a certified nonpublic school (NPS), Echo Horizon has built a fully integrated program where DHH students receive the support they need to develop listening and spoken language skills while participating fully in the academic and social life of the school. The Echo Center model exemplifies best practices in inclusive education and demonstrates the positive impact of thoughtful integration on all students. This commitment to equity and access makes Echo Horizon a leader in serving students with disabilities and a strong candidate for recognition.

What is the nominee doing or have they done to benefit individuals with disabilities in the past year(s)?

For over 40 years, the Echo Center at Echo Horizon School has created and sustained an inclusive educational environment that directly benefits students who are deaf or hard of hearing (DHH). In recent years, the program has continued to model best practices in inclusive education by fully integrating DHH students into general education classrooms alongside their hearing peers. This approach promotes empathy, respect for differences, and strong communication skills across the entire student body.

Echo Center teachers work in close partnership with general education teachers to provide individualized support through small group instruction, language scaffolding, and regular checks for understanding. Classroom hearing technology ensures that all students can clearly hear instruction and participate fully in class discussions. This model not only supports the academic and social growth of DHH students, but also fosters a school culture rooted in compassion, collaboration, and accessibility for all.
