<u>RECOMMENDATION:</u> Staff recommends the City Council adopt an ordinance amending Chapter 9.08, Streets and Sidewalks, and Chapter 9.10, Parks, Public Buildings and Property, of the Culver City Municipal Code, by adding a new Subchapter 9.08.200, et seq., and repealing and reserving Sections 9.10.025, 9.10.030 and 9.10.040, relating to tree removal. <u>BACKGROUND/DISCUSSION:</u> At the City Council meeting of June 10, 2013, the City Council introduced the ordinance by a unanimous vote (5-0). Tonight, the ordinance is brought back for adoption. <u>FISCAL ANALYSIS:</u> Staff does not believe that the ordinance will result in a significant increased burden on staff. Additionally, the existing fee schedule includes fees that are intended to offset the staff time associated with processing tree removal applications and appeals (\$75 each).
