23 6. The City Manager, or designee, as agent of the City of Culver
24 City, is hereby authorized to conduct all negotiations, and to execute and submit all
25 documents including, but not limited to, applications, agreements, amendments,

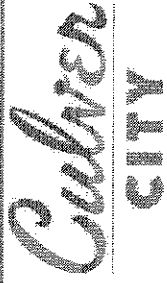

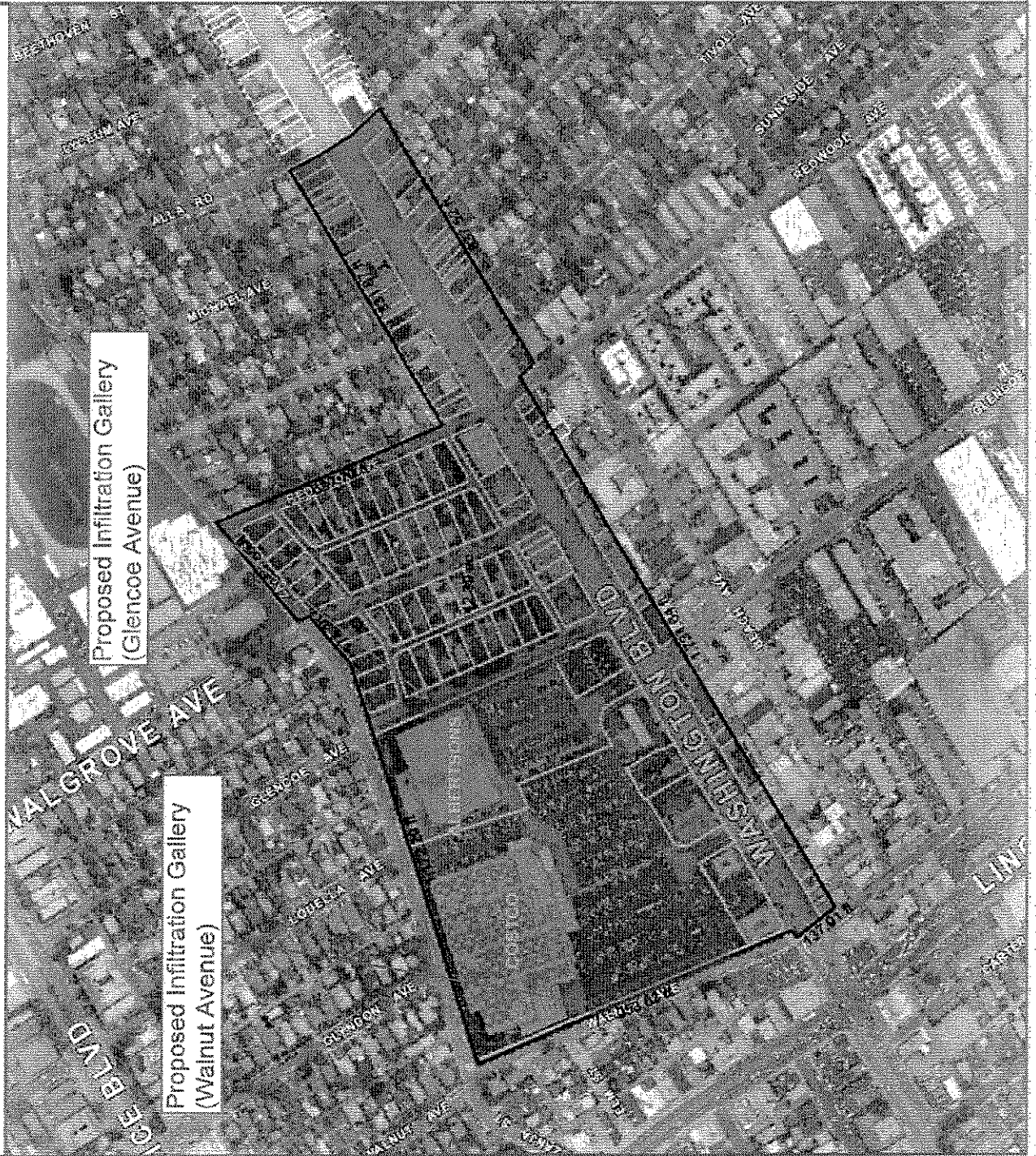
