#### In-Depth Discussion of Economic Development: Definitions, Goals and Cooperation

Member Pracher distributed information to Committee Members; discussed defining economic development; improving the health and vitality of the community; workforce education; activities of the Statewide Chancellor's Office; advancing California's economic growth and global competitiveness; training; activities of the Community College; workforce education; partnerships; and the focus of the State Chancellor's Office.

Sol Blumenfeld, Community Development Director, discussed the City perspective on economic development; growth; attracting the right kinds of businesses; property; goal setting; the Redevelopment Agency; finishing stalled Redevelopment projects; promoting the health of the local economy; providing jobs; and improving the quality of life in the City.

John Nachbar, City Manager, Culver City, discussed economic development; education; workforce skills; quality of life; and clarification on what is meant by economic development.

Discussion ensued between staff and Committee Members regarding the broader definition of economic development; connectivity; quality of life; setting the focus of economic policy and development; the net gain of the flow of dollars coming into a community; bringing in outside dollars; sustainable growth of local businesses; infrastructure and services; housing; crime; the importance of education; providing an educated workforce; Southern California Association of Governments (SCAG); having on demand education for an on demand economy; providing continuing education; the role of community colleges; adapting quickly to changing economic situations; neighborhood development; living within a reasonable distance to the workplace; the growth of small businesses; areas identified by the Los Angeles County Economic Development Corporation: advanced transportation technologies, bioscience, alternative fuel, and digital media; involving local businesses; and integrating the goals and resources of the City and West LA College.

Member Pracher discussed bioscience and digital media; services provided by the College; responding to industry demand for skillsets; industry standard certifications; providing training for below-the-line jobs; connecting kids with digital pathways; training the current workforce; developing entrepreneurs; partnerships; materials and facilities; customized training; proposals for the future; Strong Workforce Initiative monies; building bridges between the community college system and local economic business development within a community; and accountability.

Discussion ensued between staff and Committee Members regarding the Pathway Initiative; robotics; developing the support system; culinary; outreach; stakeholders; increasing the level of contact with companies; helping students clearly define their future; providing space to incubate industry; Virtual Reality; off-campus classes; other facilities; effective collaboration; marketing; facilitation of research; increasing the presence of West LA College in the community; the many components included in Virtual Reality;
