Michelle Weiner provided background on herself; discussed growth in the area; the Culver City Bicycle and Pedestrian Advisory Committee (BPAC); and she indicated being part of the three person BPAC Active Transportation Subcommittee tasked with engaging West Los Angeles College (WLAC) to work together to create active transportation infrastructure.

Art Nomura provided background on himself; discussed mass transit connections; Americans with Disabilities Act (ADA) transportation standards; car sharing programs; worsening traffic; the opportunity and responsibility to encourage students to use active transportation; he discussed benefits of active transportation; and indicated a desire to work with the Committee.

Discussion ensued between meeting participants, staff and Committee Members regarding the definition of active transportation; number of students per day on campus; options; active transportation as it pertains to WLAC; participation of WLAC in the Culver City General Plan; agendizing a discussion about active transportation for the next meeting; a suggestion to have a member of WLAC on the BPAC; and a potential partnership with the BPAC.

# Update on the Sound Wall

Member Limbaugh provided an update on the sound wall and discussed a handout provided to the Committee and meeting attendees; current construction projects; meetings between WLAC and neighborhood associations; the presentation to the subcommittee of the Board of Trustees; the vote to approve demolition of the sound wall; the sound study and corresponding effects on traffic surrounding the area; the public comment period; the demolition contract; and the status of 10100 Jefferson.

Discussion ensued between staff and Committee Members regarding portions of the wall being demolished; establishing communication with the Culver City Unified School District (CCUSD) about traffic impacts; the meeting with the Chancellor where it became clear that the City did not have any input on their current decision making process; encouragement to Committee Members to attend the public meeting on November 28; and agreement that information be sent to the City about the public meeting.

#### Economic Development

Member Eriksson reported that the City Council had approved an economic development strategy study at the November 12, 2018 City Council meeting with a report due in spring or early summer 2019.

Todd Tipton, Economic Development Manager, discussed the 2014 report; implementation of goals; changes to the economy and businesses in Culver City and the need for new goals and objectives; the Requests for Proposals (RFP) process; strategies for the economic consultant; outreach; and the plan to have the report completed by April 2019 to present to the City Council.

Keith Jeffreys, United States Veterans Artists Alliance,

requested clarification about changes to the Culver City economy.

Todd Tipton, Economic Development Manager, discussed the 2014 Plan; the influx of prominent businesses into the City; improvements to the economy; reliance on retail sales; ecommerce; the update to the General Plan; workforce housing; finding ways to preserve and enhance retail sales; cultural tourism; and coordinating economic development with the General Plan to identify needs and how and where recommendations can be provided.

# Workforce Development

Member Limbaugh discussed the Los Angeles/Orange County Regional Consortium (LA/OC RC) based on workforce development in response to California Community Chancellor's Program, Doing What Matters, the Jobs and the Economy, focusing on developing partnerships.

Allison Tom-Muira, Dean of Adult and Continuing Education, discussed colleges in the LA/OC RC; monthly meetings; funding from the State Chancellor's Office; groups working together on proposals to address high priority sectors and others; the Data Collection and Analysis Team; labor market information; aligning college programs to employment and workforce demands; building relationships to get proposals approved; recommendations to the President's Council; energy, construction and utilities; the custodial technician program; the partnership with the International Facilities Management Association; adoption of some of the curriculum for a new certificate program to introduce students interested in business with a focus on facilities management in large public sector facilities; placing a focus on Health Sciences; funding for the curriculum, roll out and marketing; Health certificate programs; Retail and Hospitality programs; new courses being considered from another international hospitality organization; short term certificates; she explained non-credit programming used as a bridge to get people into credit programs that will lead to a Bachelor's degree; ensuring that training and curriculum is up to date with future work force needs; seed money to launch industry partnerships; and she discussed other pathway programs.

Member Limbaugh discussed the process for hiring new faculty; analysis of work force data; and work with the Los Angeles County Office of Education for business and information workers to help people move out of extreme poverty into the work force.

Cari Hildebrandt, Associate Dean of Westside Extension, discussed the Business Information Worker Program; the partnership with the Los Angeles County Office of Education; public assistance participants; motivated workers who make it through the program; she reported that WLAC had received an award recently for 100% placement from the Construction 101 certificate program; discussed the Uniquely Able Program for developmentally disabled adults.

Member Limbaugh reported that WLAC has the only Department of Labor recognized Apprenticeship in Aerospace Engineering program in the country; discussed the expansion of the program; he stated that WLAC is the District leader in white collar apprenticeships in engineering and public health; discussed available wrap around services at WLAC to assist homeless students and programs to provide food and clothing; and he noted the shift in how community colleges are looking at their mission.

Member Fisch offered to connect WLAC with the Safe Parking program.
