Art Nomura discussed ways to encourage active transportation; other cities around the world with successful active transportation; the Metro Bike Hub; the LA CoMotion Conference; the Los Angeles Clean Energy Initiative; bike racks at West LA College; bicycle security; weather protection; the importance of providing secured parking; and he felt that providing safe, secure and protected parking would go a long way to encourage bike riding.

Michelle Weiner discussed food sharing at West LA College, and a student led initiative at UCLA to establish a thrift storeroom where students and faculty can shop for free with a grant that provides free feminine hygiene and birth control products.

Discussion ensued between Ms. Weiner and Committee Members regarding the food pantry at West LA College; the West Wardrobe; other community colleges that provide resources for students; climate change courses at WLAC; working toward being Los Angeles' first fully sustainable campus; urban farming; and programs at other community colleges.

Active Transportation and Mobility Options Discussion

Discussion ensued between meeting attendees, staff and Committee Members regarding incorporating mobility modes; creating a bike path around campus; removal of the wall; tree trimming; incorporating bicycle stands and protection in new plans; the joint meeting between the Bicycle and Pedestrian Advisory Committee (BPAC) and the City of Culver City/WLAC Liaison Committee; county ownership of the roads; paving opportunities; removal of a homeless encampment; finding a contact for the county; easing traffic; bus riders; hunger and homelessness throughout the Los Angeles Community College District (LACCD); the volume of bus riders; the agreement with Metro for a University Pass for LACCD; start date; TAP cards; participating colleges and bus lines; marketing and public relations for the U-Pass (U-Pass) and the bus app; signal priority; real time GPS tracking; displays; increased ridership; transit advocacy; building relationships with advocates; wrap around services; management of basic needs services; clarification that social services are not within the college mission statement; unfunded mandates; funding; legal aid; child care; AB302; required safe parking on campuses; compassion vs. resources; City Council direction to explore safe parking on Jefferson Boulevard; partnering to provide safe parking; the requirement that safe parking facilities be provided on campus; transitional housing access and vouchers; overnight parking; the changing face of community colleges; and coordination and follow up.

Update on Sound Wall and Other Construction at WLAC

Dr. James Limbaugh, West Los Angeles College President, discussed the Mayme Clayton collection; partial displays to keep the collection in front of people; highlighting the Mayme Clayton collection for Black History month in February; access; initial discussions about keeping the collection in a dedicated space in the new library; funding; he presented pictures and diagrams of new construction; discussed the demolition of 12 buildings; growth; attendance numbers; online classes; creation of a signature building that models sustainability; and the process and timeline.

Discussion ensued between meeting attendees, staff and Committee Members regarding location of the construction; noise levels; the parking lot considered for AB302; LEED Certification; the Master Plan for WLAC; College Boulevard; age of the school; and encouragement to visit the campus.
