eComment: Hello committee, my name is Herbie Gelman and I reside at the end of Jackson Avenue directly next to the gate leading to the Ballona Creek. I adamantly oppose the idea proposed by the BPAC to permanently open the maintenance gate that was never designed a an access point to the bike path. There are so many safety hazards that would be created by turning this narrow street into a new access point to the Ballona Creek bike path. There are th homes, mine included, at the end of Jackson where all of the driveways are blind to the gate. The only way we can exit our driveways is to back up within inches of the gate in order to hear northbound on Jackson. If the gate was left open we would not be able to see anyone exiting path onto Jackson, nor would they be able to see us, which would create constant potential fo serious collisions. This street was never engineered with the thought of bicycle/pedestrian traf coming from the bike path and entering the street at the end of the cul-de-sac. Additionally the are many small children who reside on the block and having the gate open would create opportunity for a child to wander onto the bike path or even worse down into the creek which could be deadly. This creates massive liability for the city. There are 2 entrances to the bike pa one at Duquesne and one at Overland which are just blocks away on both sides of Jackson. T entrances not only have dedicated bike lanes leading to them but were also designed specific to have a safe way to merge into the path traffic. It is crazy to think opening an access point at Jackson, which has blind spots from both directions, would be a safer way for people to enter bike path where bicyclists are regularly traveling at 20+ mph. All members of my family are av bikers and we cherish the ability to bike all over the city. I applaud the efforts of the BPAC to create new and safe pathways throughout the city for bicyclists and pedestrians but new acce-

should not be created at the expense of the overall safety for all residents. The BPAC wants to rush this proposal through to the council for an immediate vote. As far as I can tell there has no been a safety study and/or an environmental impact study done to evaluate this idea. I implore you to stop this process until the various safety concerns I have outlined may be addressed. I have asked members of the city council and members of the BPAC to come meet with resider of Jackson to discuss the concerns we have, most have declined. Members of the BPAC have stated that Jackson Avenue would be an experiment and if the experiment works they would seek to create new access points at the end of all residential streets that abut the bike path. Ir my opinion you should not "experiment" with the safety and well-being of your residents. The current access points are more than adequate to handle the flow of traffic in and out of the city but most importantly they are safe for all. Thank you for your consideration.
