





Bottles, bags, balloons. Thank goodness we live adjacent to Los Angeles where we can purchase any of the considered banned items. Do as you wish and so will I.



At public events such as races (the Screenland 5K) and others, hydration is important and not everyone will have or carry their own water bottles. For sanitary reasons, water bottles should not be shared. Plastic water bottles are also packed by scouts (in small quantities) and in emergency preparedness kids as safe, sanitary, essential emergency items. 



"Recyclable" plastic bags are also likely to be thrown away, but are significantly more expensive. Most takeaway food services need some sort of water-protective barrier to prevent leakage of juices and sauces in the delivery process. Angry customers whose clothes, tables, or transportation has been soiled will frequently post negative yelp reviews and demand small businesses pay cleaning costs.
