Mayor Lee expressed eagerness to attend the event noting that he had served on the Martin Luther King Jr. Committee for many years prior to becoming a Council Member.

**Community Announcements by Members/Information Items from Staff**

Mayor Lee reiterated the previous land acknowledgement of the Gabrielino Tongva people that he made when reconvening the City Council meeting after Closed Session.

Council Member McMorris expressed appreciation for the land acknowledgement; announced that State Senator Sydney Kamlager would be hosting a Governor Appointments Workshop on January 11 at 6:00 p.m. with additional information on her website; she noted that staff would be discussing ways to be involved in the City; and she encouraged anyone interested to serve, noting that she was looking forward to seeing everyone at the MLK event.

Council Member Eriksson reported that the upcoming Independent Cities Seminar had been postponed to April 1-3 due to the increase in the infection rate, but would remain at the same location.

Commissioner Fisch discussed support from the Southern California Association of Governments (SCAG) Regional Council for a proposed citizens' initiative to preempt state laws regarding land use if local law is different; the number of speakers from Culver City for and against the issue; concern with unintended consequences; the potential for regionalism; and the importance of legislative fine tuning.

Vice Mayor Vera expressed best wishes to everyone for a Happy New Year.

Mayor Lee hoped to see as many people as were able to be at the Martin Luther King Jr. celebration on January 15 and at the Kingdom Day Parade on January 17 in Los Angeles; discussed innovative ideas from Dr. King and the simplification of his life; and he encouraged people to be safe.

Mimi Ferrel, City Clerk Specialist, announced an interim recruitment to fill vacancies for the Advisory Committee on Housing and Homelessness, the Civil Service Commission, and the Fiesta La Ballona Committee with applications accepted until January 31, 2022 and more information available online at [culvercity.org/serve](http://culvercity.org/serve) or by calling (310) 253-5851.

Mayor Lee invited public comment.

The following member of the public addressed the City Council:

Khin Khin Gyi expressed dissatisfaction with the plans which she pointed out did not include pedestrian refuge nor a landscaped mini-park as was indicated in the plan; she noted that the project was still in violation of the Americans with Disabilities Act (ADA); she asserted that a traffic light was needed; stated that it was illegal for a bicycle to pass through the traffic island; and she expressed concern with liability.

Discussion ensued between staff and Council Members regarding a traffic signal vs. a flashing light; sounds and vibrations with

crossings; the design process; design improvements; the potential for a traffic signal in the future; reducing crossing distance for pedestrians; ADA compliance; neighborhood outreach and sentiment; the temporary grant funded design; gathering data; audible signals; proposed improvements; adding a crossing light; and proximity to the nearby school.

Yanni Demitri, Public Works Director, provided an update on the project noting various delays.

MOVED BY COUNCIL MEMBER FISCH, SECONDED BY COUNCIL MEMBER MCMORRIN AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL APPROVE ITEMS C-7 AND C-9.

Jeremy Green, City Clerk, indicated that through an oversight, Mark Lipman had not been called to provide comments on Item C-5.

Mark Lipman discussed the Small Book Publishers Fair and invited Mayor Lee to give the welcoming speech at the Festival noting strict observance of COVID protocols and an alternate date if necessary.

Mayor Lee expressed interest in participating if his schedule allowed and asked Mr. Lipman to provide further information.

Onyx Jones, Chief Finance Officer, introduced the item and provided a summary of the material of record.

Tevis Barnes, Housing Programs Administrator, discussed the elimination of Redevelopment; lack of funding for affordable housing production or services; lack of access to affordable housing throughout the state; and the definition of and formula for affordable housing and workforce housing.

Onyx Jones, Chief Finance Officer, discussed potential funding sources for affordable and workforce housing projects; General Obligation Bonds vs. a Parcel Tax; Lease Revenue Bonds; potential scenarios and revenue generated; assistance to the

Culver City Unified School District (CCUSD); and she presented a proposed timeline.

Discussion ensued between staff and Council Members regarding appreciation to staff and the Finance Advisory Committee (FAC) for their efforts; inclusion of unimproved land; and Article 34.

Mayor Lee invited public comment.

The following members of the public addressed the City Council:

Stephen Jones expressed appreciation for the presentation; noted the need for affordable housing; discussed the number of low income housing units built in the City vs. state requirements; the affordable housing overlay proposed by Mayor Lee; incentives; competition for federal money; Senator Kamlager's LA county affordable housing measure; delays; the need to give the City the money and the authority to build affordable housing; he asked that staff be directed to study the most ambitious ballot measure that would pass with the voters; and he thanked Council Member McMorris for raising the issue.

Marta Valdez was called to speak but did not respond.

Carolyn Libuser discussed meeting current needs; the importance of specificity; and she felt that people were already paying enough taxes.

Ben Needleman indicated having no comment

Burt Bochner was called to speak but was not present on Webex.

Elias Platte-Bermeo was called to speak but was not present on Webex.

Kate Ainslie thanked Mayor Lee for being cognizant of the time of citizens; she echoed comments from Stephen Jones; and she felt that everything possible should be done to create more affordable housing for teachers and those working in the City as well as housing for those who are experiencing homelessness.

Nancy Barba expressed appreciation for pushing the affordable housing discussion forward; echoed comments from Stephen Jones; agreed that much could be done and affordable housing still might not happen; discussed raising funds to attract developers; creating opportunities for housing development; the Regional

Housing Needs Assessment (RHNA) cycle; and she asked that the matter be treated with a sense of urgency.

Gary Guthman was called to speak but was not present on Webex.

Khin Khin Gyi expressed appreciation for the presentation; concern with consideration of workforce housing without the input of frontline workers; she proposed a survey to the workforce to see who wants to move and live in Culver City; and she proposed revisiting the funding portion after the pandemic.

Gary Guthman was called to speak but could not be heard.

Freddy Puza expressed appreciation for the presentation of a tangible option to create affordable housing; discussed the need for housing for all income levels and for those who provide services; climate change; the need for multiple tactics to address issues; and he asked that staff be directed to study the issue and propose the best method and ballot proposal.

Jeannine Wisnosky Stehlin noted the importance of protecting existing residents and retaining existing businesses; discussed bonds and taxes paid by residents over the past 20 years; the survey conducted before the pandemic; economic hardship; and she listed the numerous Measures and the School Bond approved by voters noting that people need to be informed about what has already been done before moving forward.

Gary Guthman was called to speak but could not be heard.

Michael Ainslie expressed appreciation to Council Member McMorris and Mayor Lee for their leadership and advocacy; expressed support for the comments made by Stephen Jones; and he invited everyone to take the opportunity to support housing.

Bryan Sanders expressed support for addressing the housing issue but disagreement with methods proposed to address it; he opposed adding taxes and mortgaging the future with a bond; questioned why there were no other proposals on the table; expressed support for the efforts of City staff; and concern with the narrative running through YIMBY (Yes In My Back Yard) law that if you own a home you are rich.

Kelli Estes did not feel it was necessary to live on top of each other to combat climate change; discussed affordable housing; funding; existing affordable housing in the City; concern with neglected City infrastructure; additional parcel taxes; concern

with debt being built; money spent on different City programs; state and county funding; she stated that residents were taxed the highest and businesses the lowest; and she proposed fixing the business license tax noting that businesses were driving the need for housing.

Jamie Wallace provided observations about serving on the Citizen's Bond Committee for money given to CCUSD noting that the money goes fast; she discussed shifting priorities; money meant for air conditioning; crumbling school buildings; concern as to whether state and federal funding has been exhausted; Measure H; teacher and staff housing for CCUSD; the need to poll teachers as to what they want; costs to build; number of units generated; and she expressed support for comments from Khin Khin Gyi, Bryan Sanders and Jeannine Wisnosky Stehlin.

Marci Baun echoed comments made by Bryan Sanders, Kelli Estes, Jeannine Wisnosky Stehlin and Jamie Wallace; noted the struggle for many residents to pay the already high taxes; and she wanted to see more proposals available than a parcel tax.

Andrea Schainen was called to speak but was not on Webex.

Andrew Lachman, FAC Chair, indicated that the Committee was ready to assist in identifying funding to meet needs; discussed staff shortages; competitiveness to attract employees; different approaches requiring ballot approval and some that do not; other forms of housing for the homeless; Council purview and assistance from the Committee; and he invited people to attend the joint meeting with the Parks, Recreation and Community Services Commission and the meeting with participatory budgeting.

Mayor Lee received clarification regarding options that may not need to be on the ballot including leveraging existing assets and different kinds of bonds.

Michelle Weiner echoed comments made by Freddy Puza regarding the importance of providing affordable housing in the community and she indicated trust in the subcommittee and staff with the help of the FAC to come up with strategies.

Patricia Bijvoet noted the need for workforce and affordable housing; discussed the insufficiency of current funding sources; the complexity of the situation; and support for creating a subcommittee to find ways to fund affordable housing.

Kelly Kent congratulated Mayor Lee; expressed appreciation to Council Member McMorris for bringing the item forward, to staff for their efforts, and to the City for their support of CCUSD's exploration of an affordable workforce housing measure; she provided an update on CCUSD efforts; discussed housing to support low income and unhoused families; the survey of staff interest conducted; formation of a committee of union stakeholders and district representatives; she was looking forward to hearing the direction of the City; and she expressed appreciation for the consideration of partnership on the important issue.

Disa Lindgren congratulated the new Mayor and expressed appreciation for the land acknowledgement; thanked Council Member McMorris for bringing the conversation forward; discussed the importance of the issue; funding from the City; lack of action on the item for decades; appreciation for the thoughtfulness of staff in considering the matter; and she expressed full support for moving forward.

Ronald Boykin was called to speak but was not present on Webex.

Patrick Meighan, Culver City for More Homes, discussed the need for stability, supply and subsidy; thanked Council Member McMorris for bringing the matter forward; and he asked the City Council to support the item.

Discussion ensued between staff and Council Members regarding data points from the CCUSD Workforce Housing Survey; addressing gaps in meeting community member needs; urgency to the issue; climate impacts; finding paths to housing for those working in the City; funding sources; those who support affordable housing but not the proposed solutions; finding a way forward; appreciation to staff for their work; support for the ballot measure, creation of a subcommittee and a partnership with CCUSD; dissolution of the Redevelopment Agency by the state; the feeling that cities should join together to push the state for funding; the Bill proposed by Sydney Kamlager; the responsibility of the state; zoning changes; concern with raising taxes on people with a fixed income; concern that the action would not help existing residents; the need for a state run rental assistance program; ensuring money goes where it is needed; concern with creating a financial burden; the suggestion for an emergency rental assistance program; focusing on the primary responsibilities of the City; staff shortages; the 20% vacancy in the City; the Housing Accountability Act; systemic failures; money brought into the City for housing; current

surpluses; coming deficits; the need to create sustainable programs; Tax Increment Financing; siphoning revenue from other entities; taxes in other cities; the need for more study; the need for support of the item; low trust in government; timing; the business license increase proposed by the FAC; demands for service; timing; concern that November is too soon for a ballot measure; support for creating an ad hoc subcommittee or assigning it to the Housing Subcommittee; and support for collaboration.

Additional discussion ensued between staff and Council Members regarding creation of a bond vs. a parcel tax; SB 579; incentivizing development of affordable housing by developers; support for studying the best way to address the issue; concern with passing on another tax to residents; the need to create a robust anti-speculation policy; limiting corporate housing; dissuading foreign ownership; vacancy taxes; anti-flipping provisions; owner occupancy; ways to provide the level of affordability being sought; support for study by the FAC; including the partnership with CCUSD in the study; comments by the FAC Chair regarding alternative ways to raise revenue to a ballot measure; the presentation from Urban Futures; securing assets with a Lease Revenue Bond; bonds that do not require a vote of the public; current debt obligations; the preferability of a revenue source that does not include acquiring debt; debt essential for large infrastructure projects; different ways to use a dedicated revenue source for housing; added flexibility with a parcel tax; allocating a portion of retail cannabis sales; reparations in the form of housing as part of the apology for the history of the City as a sundown town; Prop 209 concerns; other cities that have put similar policies forward; applying housing funds for a specific people; Business License Tax Revenue; funding allocation; manufactured polarization; addressing the homelessness crisis; shared responsibility; support for a parcel tax to ensure an ongoing level of funding; the need for consistent response; the complexity of housing and homelessness and the need for a multi-faceted approach; the need to take action this year; the percentage of unhoused individuals experiencing substance abuse and mental issues; current programs to address the issue; length of processes; increased numbers of homeless and housing insecure people; intentionally studying the viability of placing an item on the ballot in 2022; the need to address the homelessness crisis that is worse than it has been in almost 100 years; taking action in conjunction with others; use of funds on housing construction as well as connecting people with existing housing; providing services in the interim; the human cost of delays; premature death for those

living on the streets; the recent unprecedented rains in the City; support for a ballot measure for workforce and affordable housing; the value of having teachers and government workers live locally; creation of an Ad Hoc Workforce Housing and Affordable Housing subcommittee; support for a broad community benefits framework and collaboration with local entities; companies with a large workforce in the City; working with a coalition of business leaders; the need for substantive actions and solutions; consensus to create a subcommittee; ambiguity on ballot timing; involvement of the FAC; allowing the public to be engaged in the discussion; concern with setting a specific timeline before polling is complete; support for moving forward to find the path to success; building a coalition to get necessary voter support; the palette shelter discussion; the feeling that a subcommittee would be able to work more quickly than the FAC could; support for involvement of the Housing Subcommittee as well as the FAC, the Advisory Committee on Housing and Homelessness (ACHH) and the Equity and Human Relations Advisory Committee (EHRAC); support for getting feedback and buy-in; concern with expanding the scope of the current ad hoc subcommittee; agreement to create a separate ad hoc subcommittee; direction to the subcommittee to return to the City Council with regular reports; the importance of polling and surveying; and data to gage support of the voting population.

Element before it has been deemed legally compliant by HCD; public review of the Housing Element; AB 215; noticing; and she asked that the Housing Site Inventory be made available to the public as a searchable spreadsheet.
