The following member of the public addressed the Commission:

Mate Gaspar, Engineering Services Manager, reported writing a letter three months ago in opposition to changing Rule 3; felt that in the instance of disagreement between the Department Head, Division Manager and Human Resources on a Job Description, the Civil Service Commission should hear out the matter rather than having it appealed to the City Manager; he expressed concern with removal of the opportunity to appeal the matter to the City Council; and while he was not aware of an instance of a dispute regarding the Job Description, if there were to be one, the Culver City Management Group felt there should be the opportunity to appeal the matter to the Civil Service Commission.

Discussion ensued between staff and Commissioners regarding whether there had ever been such a dispute; preserving the ability to appeal the matter to the Commission; the current process in place; potential delays to the process; the goal to recruit; the City Manager form of government; involvement in classification studies; maintaining classifications as administrative functions; concern with wasting staff and Commission time on proforma matters; allowing for a final appeal if there is an instance where the Management Group has

a significant disagreement; the practices of other cities; focusing on larger issues such as employee civil rights issues and terminations; City culture; opposition to the change from the Culver City Management Group Board and the Culver City Employee Association; the current number of vacancies; concern with one person making the final decision; direction from City staff who have retired; Subcommittee consideration of the matter; working to accommodate an appeals process; technical comments provided to staff that were not included in the document; difficulty deciphering the document due to the formatting; addressing inconsistencies between Section 3.1 and Section 3.3; defining Recognized Employee Organizations; consistency with the Municipal Code regarding Commission involvement with the preparation of class specifications; noticing requirements; agreement to continue the item and keep the Public Hearing open; and acknowledgement of the ability to continue the item again if need be.
