Entertainment Ad Hoc Subcommittee - FLBC Member Wayne updated the Committee on the various performers the Ad Hoc Subcommittee had spoken with; shared that this year's line-up would have a mix of returning popular performers and new performers to Fiesta La Ballona. Recreation and Community Services Manager Dani Cullens informed the Committee that Recreation and Community Services Supervisor Jill Thomsen is the 2022 staff liaison.

Sponsorship Ad Hoc Subcommittee - FLBC Member Swenson mentioned the need to begin soliciting sponsorships as soon as possible; the desire to have new sponsors in addition to those who have sponsored previously; Marcus Tiggs' decision to continue helping the Ad Hoc Subcommittee find sponsors. Recreation and Community Services Manager Dani Cullens informed the Committee that Recreation and Community Services Manager Francisca Castillo and Recreation and Community Services Supervisor Arames White-Shearin are the 2022 staff liaisons.

<u>Sustainability Ad Hoc Subcommittee</u> - No Committee Members were assigned to this subcommittee; potential appointees were discussed; FLBC Vice Chair Parker Desai mentioned the idea of partnering with the local Buy Nothing group to create a space for them at the 2022 Fiesta La Ballona.

<u>Special Activities Ad Hoc Subcommittee</u> - No report because the Ad Hoc Subcommittee is still determining what special activities will be presented; the possibility that the local Buy Nothing group participation would be handled by this Ad Hoc Subcommittee.

<u>Vendors Ad Hoc Subcommittee</u> - FLBC Vice Chair Parker Desai mentioned the need to begin investigating possible vendors; the desire to have new vendors in addition to those who have participated previously. Recreation and Community Services Manager Dani Cullens informed the Committee that Recreation and Community Services Supervisor Darren Uhl is the 2022 staff liaison.

<u>Beer & Wine Ad Hoc Subcommittee</u> - Recreation and Community Services Manager Dani Cullens mentioned looking into the request by the Ad Hoc Subcommittee for having a different group operate the 2022 Beer & Wine Garden; mentioned the

challenges for any organization, especially smaller nonprofits, to meet the City's insurance requirement; the requirement that all Beer and Wine Garden profits be donated to a local 501(c)(3). <u>Volunteer T-Shirt Ad Hoc Subcommittee</u> – FLBC Member Wayne reported that he had reached out to the Culver City High School arts group to begin discussions on the T-Shirt Art contest; contest deadline would need to be by the end of the current school year; the possibility of selling either 2022 Fiesta T-shirts and/or the 2022 Fiesta Volunteer T-shirts; the 2022 Fiesta La Ballona logo's appearance and placement on various T-shirt backgrounds. Recreation and Community Services Manager Dani Cullens informed the Committee that PRCS Associate Analyst Adam Ferguson is the 2022 staff liaison.
