DAC - (1) CONSIDERATION OF NOMINATIONS FOR AN INDIVIDUAL AND/OR ORGANIZATION FOR AN "OUTSTANDING SERVICE TO PERSONS WITH DISABILITIES" COMMENDATION; AND (2) SELECTION OF THE INDIVIDUAL AND/OR ORGANIZATION TO RECEIVE THE COMMENDATION FROM THE CITY COUNCIL.

Vice Chair Goldhaber began the discussion by coordinating how the process of reading through the list of nominees and voting for one organization and individual to receive the commendations could occur. Jill Thomsen, Recreation and Community Services Supervisor, suggested that the submissions for organizations be read first; encouraged that they pick an organization from those options, then repeat the same process for the submissions for individuals.

Vice Chair Goldhaber agreed and suggested that the committee proceed with that process. Member Carmen Ibarra read aloud the submissions for the organizations. Discussion ensued about each organization and committee members offered additional information about the organizations; committee members suggested that the nomination criteria be changed to include the percentage of the population of Culver City

residents served by each organization; Vice Chair Goldhaber suggested that the nomination criteria be revisited at another meeting as an agenda item and edited to include more detailed information regarding an organization's service area, mission statement and the percentage of Culver City residents served.

A CONSENSUS WAS REACHED WITH NODDING HEADS FROM MEMBER IBARRA, MEMBER ALVAREZ & VICE CHAIR GOLDHABER THAT IT BE AGENDIZED AT A LATER MEETING TO REVISIT THE NOMINATION CRITERIA AND SUBMISSION FORM INFORMATION FOR THE 2023 CALL FOR SUBMISSIONS OF ORGANIZATIONS AND INDIVIDUALS THAT PROVIDE "OUTSTANDING SERVICE TO PERSONS WITH DISABILITIES" DURING DISABILITY AWARENESS MONTH IN OCTOBER.

Discussion continued regarding the organization nomination submissions. Jill Thomsen, Recreation and Community Services Supervisor, noticed that Member Hoult was feeling physically ill.Melanie Morales, Recreation and Community Services Coordinator, suggested that the committee take a recess.

CONSENSUS WAS REACHED WITH NODDING HEADS FROM MEMBERS IBARRA, ALVAREZ, SOOKNE AND VICE CHAIR GOLDHABER. RECESS BEGAN AT 7:07 PM AND VICE CHAIR GOLDHABER CALLED THE MEETING BACK FROM RECESS AT 7:18 PM.

Discussion ensued between staff and Committee Members regarding the need to make a vote for the organization and then the individual that will be receiving the commendation.

Vice Chair Goldhaber led the vote for the organization to receive the commendation. Committee members Ibarra, Sookne, Hoult and Vice Chair Goldhaber voted for Friendship Factor while Member Alvarez voted for Creative Steps. Friendship Factor won with a 4 to 1 vote.

Discussion ensued about the two individuals who were nominated. Jill Thomsen, Recreation and Community Services Supervisor, shared that Justin Sandy has been a longtime volunteer for various events and programs at the Senior Center like the Senior Meal Program and various events for individuals with disabilities. Members and staff did not have information to add for Renadda Wiggins beside what was submitted. Member Hoult stated that she believed volunteers like Justin should be recognized for their dedication and work in the community.

Vice Chair Goldhaber led the vote for the individual to receive the commendation. Committee members Ibarra, Sookne, Hoult, Alvarez and Vice Chair Goldhaber unanimously voted for Justin Sandy.

MOVED BY MEMBER ALVAREZ, SECONDED BY MEMBER IBARA AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL AWARD THE COMMENDATIONS TO FRIENDSHIP FACTOR AND JUSTIN SANDY FOR THEIR "OUTSTANDING SERVICE TO PERSONS WITH DISABILITIES" FOR THE YEAR OF 2022 DURING DISABILITY AWARENESS MONTH IN OCTOBER.
