Jay Coury discussed facilities built for paddle tennis that could be easily converted or used for both.

Matt Denoff provided background on himself; indicated that he was the pickleball ambassador for the City; wanted to see separate dedicated pickle ball courts; provided handouts to Commissioners; discussed conflicts between paddleball and pickleball players; lack of structure; fundraising to cover costs; and support for providing lessons at the Senior Center.

Dora Corral wanted to see the paddle tennis courts at Elenda left alone; discussed fighting between paddle tennis and

pickleball players; and she noted that people were slipping and the courts needed to be re-surfaced.

David Van Slyke thanked Chair Rickards for his efforts; discussed finding an equitable solution; the need for clear signage delineating who is allowed to play and when; dual use courts; and the policies of other cities.

Steve Mitsunaga provided background on himself; expressed support for dual usage of the courts; discussed the importance of being inclusive; he invited Commissioners to come down and see how things are going at the courts; expressed support for posting signage; and he proposed using facilities at Culver City High School.

Patricia Mooney, Senior Management Analyst, read comments from Commissioner Leonard that had been distributed to Commissioners regarding support for staff efforts to strike a balance and quell conflict; distribution of a survey; public outreach meetings at Veterans Park and Culver West Alexander Park; development of an ad hoc subcommittee; inclusion of subject matter experts on the subcommittee; and Commissioner Leonard offered to serve on the subcommittee if needed.
